

PCSC MEMBERSHIP RENEWAL GUIDELINES

Since 1956, the PCSC has evolved and grown into our fine Club today; a great facility to enjoy the freedoms provided by the 2nd Amendment of the U.S. Constitution.

With that freedom comes responsibility. We have often stated that each member is an honorary Range Safety Officer. All PCSC members watch out for each other at our Club.

Please note the annual PCSC MEMBERSHIP DUES have risen to \$100, with the PCSC ANNUAL GUEST PASS FEE now at \$50. The ANNUAL SPOUSE MEMBERSHIP FEE remains at \$10.

The PCSC membership renewal process requires the items listed below to be submitted each year:

- A) To renew your membership, please provide a copy of ONE of the following documents certifying you are legally able to own a firearm in Texas.
 - 1. A signed and identifiable receipt from an FFL Dealer showing a recent (within six months) firearm or component purchase requiring submission of a FORM 4473.
 - 2. A valid photocopy of your active and current Texas LICENSE TO CARRY (LTC) license.
 - 3. A report from the Texas Department of Public Safety online Criminal Background search with no record of felony or domestic violence. TX-DPS cost is minimal (Under \$4).
If you get no matching TX-DPS records, please print and include with your renewal media.
- B) Complete the PCSC RULES QUIZ on the next page. RULES for 'OPEN BOOK' QUIZ provided at www.parkersportsman.com.
- C) PLEASE CLEARLY PRINT INFORMATION when completing the PCSC RENEWAL APPLICATION, then sign and date the 'RENEWAL APPLICATION' and the PCSC 'RELEASE and HOLD HARMELESS AGREEMENT' form prior to return.
- D) Enclose a CERTIFIED BANK CHECK, PERSONAL CHECK, or USPS MONEY ORDER.

NOTE: Providing one of the three items listed in 'A' above is not negotiable.

The PCSC does not use professional credentials for BACKGROUND CHECKS. Documents are shredded upon verification and review. The PCSC does not require your TX-LTC NUMBER; please black out on the TX-LTC copy provided. Note: you must return the RULES REVIEW QUIZ provided. Neither the RENEWAL QUIZ nor the BACKGROUND CHECKS are kept on file but MUST BE SUBMITTED EACH YEAR. This thorough renewal process helps assure that your fellow members may legally be in possession firearms while on PRIVATE PCSC PROPERTY.
