More than half (51%) of Campbell Ridge Elementary students qualify for Free or Reduced lunches



Campbell County-wide there are more than 250 students that are considered homeless—47 of those at Campbell Ridge



Over 2,380 backpack meals go out a year which is the equivalent to more than \$11,000 of food donated to students over the course of the year.

### **Our Help is Vitally Important**

FRYSC receives limited grant funding, that's why they rely on the support we provide to be successful.

Our 1 month a year (May) covers 4 weeks. This year, we donated 256 bags of food to feed 64 children. This year the bags we provided included: Mac & cheese cups, Chef Boyardee microwavable pastas, applesauce, oatmeal, chewy granola bars, Nature Valley granola bars, Goldfish crackers, peach cups, Cup of Noodles.

By providing this help to Campbell Ridge, we are:

- Ensuring children don't go hungry over the weekend
- Providing a little food security and stability for families
- Reducing some of the stress factors families are experiencing
- Helping children have the nutrition they need to succeed in school
- Living out Christ's call to help those in need
- Making a difference in our community, 1 bag at a time

Claudia called the meeting to order, over Zoom. Paul offered an opening prayer.

Claudia read the Council Covenant.

1. SECRETARY'S REPORT: No changes to February minutes. Claudia requested corrections of two typos in the March minutes. Motion made by Sally and seconded by Jeff to approve minutes. Approved.
2. TREASURER'S REPORT: Sandy reported that we have \$45,758.17 in the checking account and \$33,371.05 in the temporary account. There are \$8,465.60 in renovation chargesto be paid. We collected \$1,050 for Ukraine support. Paul will let Sandy know where to send the money. Sandy reported we still have the funds collected for Kentucky tornado relief. Sarah will let her know where to send it. Cammy motioned to accept the Treasurer's report and pay the bills, Evelyn seconded. Motion passed.
3. FINANCIAL SECRETARY'S REPORT: Jeff reported that April giving through 4/12/2022 was \$8,246.50. The first quarter average monthly giving was \$16,625. The counting file has been updated for the 200 series ID's. A communication to the non-envelope givers will take place soon.
4. COMMITTEE REPORTS: To expedite review of individual committee reports to allow more time for discussion of other business council members reviewed committee reports prior to the meeting. Claudia moved and Sally seconded accepting the committee reports. Approved.
  - a. Worship Committee reported that Queen City Bronze is scheduled to perform May 1 st . Paul will be on vacation the end of May. Melinda will be on vacation May 1st . Coffee Hour will remain on hold for now. We need at least three more volunteers to consider bringing it back.
  - b. Trustees (Sally) reported that a piece of siding is loose on the steeple. Arrangements have been made to have it fixed. The light across the street is out. Duke is scheduled to fix it. Plans are being made to move some pews to make more room for Bell Choir.
  - c. Endowment Committee met on March 19th. There report will be coming.
5. NEW BUSINESS:
  - a. Church Directory - The last directory was done in 2017. It was reported that photos can be uploaded to Breeze to use it as a directory, the contact information is already there. Craig offered to assist members with uploading photos. The Breeze directory works especially well on mobile devices. It was decided to table using a company to do a directory for now.
  - b. Easter Breakfast will be a continental breakfast (bagels, donuts, muffins, coffeecake, fruit) this year at the Parish House.
  - c. Paul recommended we add a member of the Staff Parish Team (current members are Jeanne Greiser, Evelyn Dietz, Connie Ballinger & Karen Zimmerman) as a representative to Council. They work with hiring/supervising/evaluating staff and make recommendations for budget. A motion was made by Sarah and seconded by Janet to add Parish Team as a voting member of Council. Motion passed. They will be invited to the next council meeting.

d. Constitution Revision: In the fall of 2020 a task force consisting of Charlene Rogers, Jeff Enyart, Sarah Lester and Paul Forrey was appointed to work on a revision to the Constitution. A draft was provided for review. Sarah gave an overview. The Constitution serves as the foundation. If done well it wouldn't require updates. New By-Laws would be developed to spell out "How we do business". They could be updated as necessary. The Constitution is the skeleton, the By-Laws are the flesh. More people will need to be involved to revise the By-Laws. Everyone on Council should be part of the development. We will explore it over the next several months.

e. Passing of the Peace: It was decided to table "passing the peace" during the service for now. People seem to be greeting others before and after services.

f. Children's Chat: Craig reported that we need more people on the children's chat list. It was decided now that weekly Sunday School is back we can cut back to one Children's Chat and one children's book per month.

## 6. ADJOURNMENT: Motion made by Sally and seconded by Debbie to adjourn meeting. Motion passed.
