

## Call for a Special Meeting of Presbytery on July 10, 2019

The moderator of the Presbytery of Cayuga-Syracuse, the Rev. Tom Oak, has called for a **special meeting of the Presbytery, as has been properly requested by several different individuals, for Wednesday, July 10, 2019 beginning at 11:00 a.m.** at First Presbyterian Church of Liverpool (603 Tulip Street, Liverpool, NY 13088). The purpose of this meeting is:

1. **To examine** Benjamin Fitzgerald-Fye for ordination to the ministry of Word and Sacrament and, upon successful completion of the examination, request that Kiskiminetas Presbytery, Mr. Fitzgerald-Fye's presbytery of care, hold the ordination service for Mr. Fitzgerald-Fye.
2. **To examine** Benjamin Fitzgerald-Fye for membership in the Presbytery of Cayuga-Syracuse pending his ordination to the ministry of Word and Sacrament in Kiskiminetas Presbytery on July 21, 2019.
3. **To approve** the call of First Presbyterian Church of Scipioville, Scipio Center, New York to Benjamin Fitzgerald-Fye as their pastor (75% time), pending his ordination, beginning August 1, 2019 at the following terms, and **to enroll** him as a member of the Presbytery of Cayuga-Syracuse effective August 1, 2019:

4. If requested, **to authorize** the Leadership Team to set the date for the installation of Ben Fitzgerald-Fye, to appoint an Administrative Commission for that purpose, and to dismiss the Administrative Commission at the conclusion of the Service of Installation.

5. **To approve** the call of the Presbytery of Cayuga-Syracuse to the Rev. Karen Chamis, of National Capital Presbytery, to undertake the office of Resource Presbyter of this Presbytery beginning August 12, 2019 at the following terms:
