

Expectativas de aprendizaje a distancia

Distance Learning Expectations

El Departamento de Educación de California ha establecido un requisito mínimo de minutos de instrucción diarios durante el aprendizaje a distancia. Se espera que todos los estudiantes asistan a la escuela de forma remota desde casa.

- Los requisitos de minutos de instrucción son los siguientes:
 - TK / K 180 minutos diarios
 - 1-3 230 minutos diarios
 - 4-8 240 minutos diarios
- Los minutos de instrucción se cumplirán mediante una combinación de aprendizaje asincrónico y sincrónico. La asistencia y participación serán monitoreadas diariamente.
- Los estudiantes se conectarán por Zoom durante los periodos de aprendizaje sincrónicos.

The California Department of Education has set a minimum requirement on daily instructional minutes during distance learning. All students are expected to attend school remotely from home.

- *Instructional minute requirements are as follows:*
 - *TK/K 180 daily minutes*
 - *1-3 230 daily minutes*
 - *4-8 240 daily minutes*
- *Instructional minutes will be met through a combination of asynchronous and synchronous learning. Attendance will be tracked daily.*
- *Students will connect synchronously via Zoom.*

Los estudiantes de secundaria se conectarán con sus maestros de forma sincrónica (en vivo) de lunes a jueves para recibir instrucción en las materias asignadas. Los viernes, los estudiantes trabajarán independientemente y tendrán oportunidades de recibir enriquecimiento y apoyo académico. **Los horarios individuales de los estudiantes y las expectativas detalladas se irán a casa la próxima semana.**

*Middle school students will connect with their teachers synchronously (live) Monday through Thursday to receive instruction in assigned subjects. On Fridays, students will work independently and will have opportunities to receive enrichment and academic support. **Individual student schedules and detailed expectations will go home next week.***
