SUMMER SCHOOL DRIVER EDUCATION**

- Location:** Summer School will be held at Lake Park High School, East Campus
- Dates:** Class will begin Monday, June 12, 2017, at 7:30 a.m. at Lake Park High School East Campus and will be completed by Friday, July 21, 2017. **We will be holding classes: Monday through Friday throughout the entire summer school session. Summer Driver Education classes will not meet from Monday, July 3 through Friday, July 7.**
- Prerequisite:** Students must be age 15 by Monday, June 12, 2017.
Students must reside within the Lake Park district boundaries
All students must have successfully passed (8) eight classes within the last two semesters.

- Attendance:** State Law requires that each student complete a minimum of 30 hours of classroom and (6) six hours of behind-the-wheel instruction. Any combination of absences and tardies which totals three (3) days will result in the student being removed from Driver Education.
- Class Size:** Class size will be limited. Acceptance will be based upon the school you attend and the age of each student enrolled. (Oldest to youngest)
- Instructors:** Instructors are full time driver education staff members at Lake Park High School.
- Registration:** Monday April 3, 2017 to Friday, May 5, 2017.

Students, after you have registered, you must see either Mr. Chellson or me to obtain a Rules of the Road booklet and directions on how to fill out the permit application at home before the program starts. The purpose is for the students to take the written exam, eye exam and turn in their signed permit application with a check or money order payable to the Secretary of State in the amount of twenty (\$20) dollars so that the driver education department does the process in getting your child’s permit so you do not have to.
