



JONNYCAKE CENTER

NORTH KINGSTOWN FOOD PANTRY

We service any resident of North Kingstown who has a food need. Call 885-3663 to make an appointment. If it is your first visit, you will need to fill out a simple brief form and show some form of residency. We provide one week (21meals) of groceries and a few hygiene items such as toilet paper and soap.

When you arrive for the appointment, a volunteer will deliver the groceries to your vehicle. We also have volunteers who can deliver if needed. During this crisis we know there are many individuals and families who may for the first time need food assistance and are not aware that we are available.

Quotes of the Week

"Let us pray for the dead, those who have died from the pandemic. And let us also pray in a special way for the 'anonymous' dead. We have seen photos of common graves. There are so many there." Pope Francis, speaking last Thursday. "Pope prays for anonymous victims of coronavirus." *Crux*. April 30, 2020.

"Should a pastor suffer the loss of liturgical communion and Eucharistic participation along with his community? This is the decision I have taken (as the pastor) because I think I should share the Eucharistic fast with the community to whom I belong. As a pastor and presbyter, I believe that my presbyterial ministry is not defined by the power or need to celebrate Mass. The Sacred Liturgy belongs to the Church and I, alone, do not constitute the Church. When the community to which I belong cannot gather for liturgy I share our deprivation. Many would not agree with me. In making this decision I do not see that my priestly identity has been put at risk. Rather, I see my role as one who serves the life of the community by leading the community's worship is being defined by ministry and not by role. Liturgy is an activity of the whole community. When the community cannot gather, liturgy cannot be celebrated."

"One of the most difficult moments that I've had as a bishop was participating in the decision to close our churches and to shut down the celebration of Mass with a community. Mind you, it was the right decision. I emphatically disagree with those who argue that the bishops caved in to the pressure of the secular state in making this determination. That's nonsense. There are some very real tensions between Church and state and sometimes we have to make a stand—a good example being our vigorous opposition here in California to the legislature's attempt to violate the seal of confession. But this is not one of those cases. Instead, we bishops agreed with the secular authorities that the churches should be closed, precisely for the well-being of our people. Having said that, the suspension of public Mass has been painful for everyone—and the principal reason for that pain is the forced fasting from the Eucharist."

"The days of the distant Pope, being carried around wearing a huge tiara are over. People want someone 'real' now and I think the Church ignores this at its peril... Francis is loved by the people, though certainly not by the Curia. I'm sorry to say there's a 'dampening' going on to prevent Francis from becoming too popular. Benedict seems to be making Francis' life a misery with his opinions... Unfortunately there are many idealistic young priests in Rome, living in a bubble, who want to take the Church back to medieval times, and imagine Francis is wrong to reach out, but their way is losing Church members daily."

"Too often, our bishops respond by answering the questions and criticisms that they wish people had or that they think that people should have instead of the ones they actually do have. It is a pastoral failure of communication that stems from a failure to listen."

"In a new report after decades of ambivalence, Germany's council of Catholic bishops has finally admitted to the church's complicity in the actions of the Nazi regime during World War II... The 23-page document by the council reportedly states, 'Inasmuch as the bishops did not oppose the war with a clear 'no,' and most of them bolstered the [German nation's] will to endure, they made themselves complicit in the war.' It added: 'The bishops may not have shared the Nazis' justification for the war on the grounds of racial ideology, but their words and their images gave succor both to soldiers and the regime prosecuting the war, as they lent the war an additional sense of purpose.'"

“The current restrictions are challenging but are for the common good and the protection of everyone across our island... While we all look forward to the day when we can again gather together for collective worship in our churches, we accept that at this time it would not be appropriate to consider a full return to such gatherings, apart from the limited number of people who are able to meet for funeral services.”

Statement of Irish Christian leaders of the Roman Catholic Church, the Church of Ireland, the Methodist Church in Ireland, the Presbyterian Church in Ireland, and the Irish Council of Churches. “Irish churches say ‘at this time it would not be appropriate’ to start public worship.” *Crux*. “Opening our churches would convey at this point a false sense of security about the risks of public gatherings here in El Paso. Many of our most fervent members are also people in the categories of highest risk, our senior citizens and those with underlying health conditions.”

The Catholic Dioceses in Georgia said Thursday in a statement that it is ‘not authorizing the return to congregating at churches or making our churches available for devotions’ through May.”

“Maryland’s oldest Catholic college preparatory school for girls, an institution that resolutely continued educating young women in the same East Baltimore building for more 170 years, announced Tuesday that it is closing its doors... They cited declining enrollment, financial difficulties and a need to raise millions of dollars, in part to cover at least \$5 million in building repairs, as some of the reasons for the closure.”

“Maryland’s oldest Catholic girls school, Institute of Notre Dame, announces closing.” *Baltimore Sun*. May 5, 2020.

“The Diocese of Harrisburg says due to financial stress and falling enrollment, Holy Family Consolidated Catholic School in Berwick will close at the end of this school year... The diocese says the school is \$700,000.00 in debt.”

“Holy Family Catholic School in Berwick closing.” *WNEP*. April 28, 2020.

“After 161 years of providing Catholic school education to Lebanon County, Lebanon Catholic School is closing its doors, the Harrisburg Diocese announced on Tuesday... The school is expected to reach \$2.3 million by the end of the school year.”

“Holy Family College in Manitowoc [Wisconsin] will cease operations at the end of the summer term and discontinue all operations by August 29. In a Monday release, the Franciscan Sisters of Christian Charity Sponsored Ministries says the decision was made due to increased operating costs, unstable enrollment, and the impact of the coronavirus.”

“Manitowoc’s Holy Family College to cease operations after summer term.” *WFRV*. May 4, 2020.

“All Saints Catholic School in Elsmere [Delaware] will cease operations at the end of this school year in June, citing the impact of the coronavirus pandemic among the factors contributing to the school’s closing... All Saints is the third school in the diocese [of Wilmington, Delaware] to announce its closing at the end of this school year. Immaculate Conception school in Elkton, Md., announced in January that it would not reopen after this year. St. Thomas More Academy in Magnolia announced in February that this would be the last year for the high school.”

“All Saints Catholic School in Elsmere to close at the end of 2020 school year.” *The Dialog*. April 30, 2020.

“After years of declining enrollment, financial struggles, and recent challenges brought on by the coronavirus, St. Joseph Catholic Academy will close at the end of June.”


