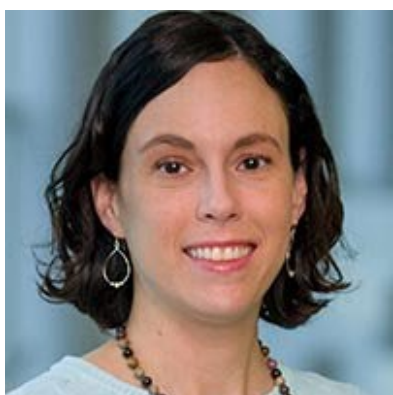


Kehinde Obikoya, M.D.
