## COURSE DESCRIPTION

This course will review the new MDS (version 1.17.0) and Resident Assessment Instrument manual (RAI-version 1.17) updates and revisions from the Centers for Medicare and Medicaid Services (CMS) effective October 1, 2019. A significant change in the reimbursement methodology for Medicare residents will also be implemented October 1, 2019. This new methodology, Patient Driven Payment Model (PDPM), will be reviewed in this course. An overview will be provided on the Skilled Nursing Facility (SNF) Quality Reporting Program (QRP) Reports and enhancements, new and revised MDS transmission errors and how to locate and use the MDS 3.0 Provider User's Guide.

## PRESENTERS

Patrice Padula, Senior Health Care Manager with Myers and Stauffer, has more than 45 years of experience in the nursing field, of which over 24 years have been at Myers and Stauffer. She routinely interprets and analyzes data collected from the MDS, trains on the RUG-III and RUG-IV resident classification models; both for Medicare and Medicaid reimbursement. In addition, she is a regular presenter in various states for MDS coding and interpretation guidelines as well as other related case mix topics.

Chrystal Daugherty is a Nurse Consultant Inspector for the Division of Health Care in the Office of Inspector General. She is responsible for providing guidance and answering questions for providers related to the Resident Assessment Instrument (RAI) and the Minimum Data Set (MDS). She is also responsible for the coordination of the IDR/IIDR process. Chrystal is a registered nurse with 12 years of experience. She has 5 years of state government experience, working for the Office of the Inspector General.
