### **List of Active Shelters**

If you and your family are in need of a shelter, please follow this link (<http://www.redcross.org/get-help/disaster-relief-and-recovery-services/find-an-open-shelter>) to find the map to find a shelter closest to you. **Before arriving at a shelter, please call that shelter to ensure that the shelter is open and has room for you and your family.**

### **Debris Removal**

You may be eligible to receive reimbursement for debris removal. TCEQ approval of debris management sites is a necessary step in the FEMA reimbursement process. You can find the Request for Approval from Temporary Debris Management Site for Debris Resulting from Declared State or Federal Disaster form (TCEQ Form-2066) at <https://www.tceq.texas.gov/assets/public/response/TCEQ-20660.pdf>.

### **Have You Flooded or Evacuated?**

If your house got flooded during the storm, then it might need to be mucked. Mucking includes activities like removing wet carpets, flooring, dry wall, mud, or other items to prepare a flooded home for drying out and renovations. Additionally, if you have evacuated your home, please be sure to cancel any recurring services to your home (like newspapers, cable, exterminator, etc.) to ensure that those charges do not continue while you are evacuated.

### **IRS**
