**Purpose:** This course provides training on and resources for personnel who require advanced application of the Incident Command System (ICS).

**Course Description:** MGT-905 ICS-400 Command and General Staff-Complex Incidents

Enhance your Incident Command skills, with a special focus on new concepts of the Incident Command System (ICS). The training and resources provided in this course will assist personnel who require advanced application of the ICS. The course will also benefit any person who has a responsibility to function in a command post managing an expanding incident.

You will participate in group activities that introduce the use of an Incident Complex and Area Command, and the interactions between Multi-Agency Coordination (MAC) entities.

**Target Audience:** The target audience for this course includes senior personnel who are expected to perform in a management capacity at an incident or event. This includes individuals who may serve as Incident Commander or as members of the Command or General Staff, Area Command, or Multiagency Coordination Group/Emergency Operations Center (EOC) management. This course expands upon information covered in the ICS-100 through ICS-300 courses. These earlier courses are prerequisites for ICS-400.

**Registration: Required**

**STEP 1: Obtain your SID #**

- **Federal Student Identification (SID) required for each student.** DHS/FEMA has directed the implementation of the Federal SID for all HSNTF funded participants. If you have attended a federal training in the past 18-24 months you may already have SID #; if so, select the option "Forgot Your FEMA SID?"

**The procedure for obtaining their number:**

Step 2: Click on "Register for a FEMA SID"

Step 3: Follow the instructions and provide the necessary information to create your account.

Step 4: You will receive an email with your SID number. You should save this number in a secure location.
