

## Emergency Management Job Openings

- **[Safety and Emergency Management Analyst](#)**, City of Eugene. In this position, you will be responsible for management of the comprehensive safety program for the Public Works Maintenance and Parks and Open Space Divisions to minimize the risk of injury or illness. Major duties include program planning and coordination, program evaluation/continuous improvement, policy and procedure development, training and testing, inspections, hazard identification and analysis, safety consultation, and influencing the safety culture. Also is an active member of the Public Works Emergency Management Program Team. May occasionally assist other Public Works Divisions and City Departments on safety-related issues. Works closely with the City's Risk Management staff including the risk/liability, employee and public safety, workers compensation, and health and fitness. **Closing April 7, 2019.**
- **[County Emergency Manager](#)**, Marion County, Salem, OR. The role of this position is to: Manage the planning, organizing, and directing of the county's emergency preparedness, hazard identification, mitigation, response and recovery programs, as related to homeland security. Evaluate and monitor disaster management. Serve as the county liaison and technical advisor to local, regional, state and federal agencies. Manage the county's communication systems. **Closes April 8, 2019.**
- **[Disaster Preparedness Planner](#)**, CareOregon, Portland, OR. The Disaster Preparedness Planner is responsible for the ongoing review and administration of an effective and efficient disaster preparedness and business continuity program. This position recruits and trains the incident management team, maintains emergency response and business continuity systems, and develops and recommends policies, procedures and strategies to mitigate the impacts of potential business disruption. **Closing date not listed.**
