"Tribal Access to Broadband. — The Committee is concerned about disparities in access to communications services on Tribal lands. The Committee directs the FCC to allow tribes to determine where the "unserved and underserved" tribal citizens are within their respective boundaries. The committee is aware that FCC broadband maps may show incumbent telephone, cable, WISPs, or other broadband providers able to provide FCC minimum broadband speed of 25/3 in areas where that service is not actually available."
