



2018-2019 CRT Project Goals

- To reduce climate-related morbidity and mortality in Tribal Nations and communities;
- To build capacity to identify and assess climate-related health threats to Tribes;
- To build climate and health adaptation capacity within Tribal governments;
- To increase collaboration and data sharing among the Tribes, the federal government, state/local governments, and other partners on issues of climate and health;
- To increase communication and information sharing about the health effects of climate change.

Eligibility – Applicants Must:

- Be a federally-recognized Tribe
- Have appropriate staff who can serve as the project contact and will take primary staff responsibility for this project
- Include a letter of support demonstrating project support from the Tribe
- Propose a project that is reasonable in scope, complements current activities at the Tribe, is not duplicative of other sources of funding and support, and advances the goals of CDC's and NIHB's climate and health work
- Demonstrate in the proposal the Tribe's commitment to the proposed efforts, including how the project further builds the capacity for that Tribe to confront the health and public health consequences of climate change
- Allow NIHB to share resources and lessons learned with NIHB, CDC, and other Tribes, Tribal organizations, and key stakeholders
- Have the capacity to complete the proposed project
- Dedicate staff and the resources necessary to complete all approved activities
- Agree to fulfill all expectations for participation



Expectations and Deliverables

1. Use CDC's
Building Resilience Against Climate Effects (BRACE) framework as a guide to developing a project.

Building Resilience Against Climate Effects



Expectations and Deliverables

Sample activities could include, but are not limited to:

- Creating a climate adaptation plan or strategy.
- Providing training to health agency personnel or other Tribal stakeholders on relevant climate change topics.
- Collaborating and holding meetings/workshops with community members and key stakeholders.
- Planning or implementing a specific intervention.
- Developing and implementing an educational campaign on climate and health.



Expectations and Deliverables

2. Provide written mid-year and final reports with deliverables.
3. Participate in one in-person meeting and/or site visit if requested.
4. Participate in monthly check-in calls.
5. Participate in up to four CRT Learning Community activities.
6. Compile findings, etc. for distribution.
7. Present at Tribal Public Health Summit.

Expectations and Deliverables

Sample activities could include, but are not limited to:

- Creating brochures/posters.
- Writing newsletters.
- Exhibiting at a health fair.
- Conducting internal training for staff, such as training health staff or attending a meeting/training/conference.
- Hosting a meeting with community partners or community members to discuss climate change and health in some capacity.



Expectations and Deliverables

1. Provide written mid-year and final reports with deliverables.
2. Participate in monthly check-in calls.
3. Participate in up to four CRT Learning Community activities.
4. Compile findings, etc. for distribution.
5. Complete project evaluation activities.



Completed Application Packets Include:

- Full application (in RFA)
 - Tribe and contact information, project and workplan section, budget
- Letter of support from Tribal leader/official
- Project coordinator resume

Be sure application is complete and that you've followed all instructions for completion and submission!



Project Goal: To + verb... The goal is the overall, all-encompassing goal for all project activities.

Objective 1: Objectives are the specific aims for your work and should be written so that they are “SMART” (specific, measurable, achievable, relevant, and time-based). You might have several different or related objectives, or only one main objective.

Activities	Deadlines	Deliverables	Person(s) Responsible
<p>Activity 1.1: Tribe will + verb... Activities are the specific tasks and work that you will engage in to accomplish your objectives. You will have more than one activity per objective. Each activity should include an expected deadline for completion. Typically, the activities should occur throughout the project period in order to provide spacing and measure progress. Be sure to break down activities into smaller deliverables. For example, don't just list “Tribe will host a meeting” as an activity. List each component, such as “Activity 1.1: Tribe will create a list of stakeholders; Activity 1.2: Tribal staff will host a planning meeting to discuss the event,” etc. Please keep numbering format for activities and objectives. Rows can be added or deleted as needed.</p> <p>Please be sure to include a full scope of work. Everything you plan to do for this project should be detailed here. You should also include NIHB obligations such as attending check-in calls and presenting at the Tribal Public Health Summit as well as submitting reports. The final report will be due July 12, 2019 and the midterm report will be due March 29, 2019. All other project activities should be completed by June 30, 2019.</p>	<p>Deadlines should be realistic and spaced throughout project period.</p>	<p>Deliverables are what you physically submit to NIHB to demonstrate achievement of your objectives (e.g., meeting notes, agenda, educational materials, final product, etc.). You should have at least one deliverable per activity. You will need to submit these with the midterm and final reports.</p>	<p>This will likely be the Project Coordinator for most activities. Please use titles here, not names.</p>
