Dear Parents,

The OHS Prom and After-Prom will be held on Saturday, April 29. The Junior Class Advisors, student representatives, and the After-Prom Parent Committee have planned an elegant Prom, and After-Prom; both events are designed to create a fun, memorable and safe evening. Attached please find the Prom/After-Prom agreement, permission forms, and Fun-n-Stuff participation form. If your child intends to participate in Prom and/or After-Prom, you will both need to carefully read, review and sign these forms. Your child will be allowed to purchase tickets to the Prom/After-Prom only if the enclosed agreement is signed and submitted.

General Overview of the Evening

Prom begins at 7:00 p.m. and is being held at The Chagrin Valley Country Club at 4700 SOM Center Road, Chagrin Falls. After-Prom will be hosted at Fun-n-Stuff in Macedonia and will begin at 11:30 p.m. For students attending both Prom and After-Prom, they will be bused from Chagrin Valley Country Club to Fun-n-Stuff and then back to the location of their car.

Prom is scheduled to conclude around 11:00 p.m., at which point students attending After-Prom will have the opportunity to change their clothes at the Country Club. Buses will then depart for the Fun-n-Stuff and After-Prom will begin at 11:30 p.m. Students not attending After-Prom should leave at the conclusion of the dance.

Students not attending Prom, but would like to participate in After-Prom must ride a bus from OHS to Fun-n-Stuff. The buses will pick up any students that did not attend Prom at Orange High School beginning at 10:45 p.m. and will depart for Fun-n-Stuff promptly at 11:15 p.m. Students will not be permitted to enter Fun-n-Stuff if they did not ride on school-provided transportation.

All students will be transported back to the location they departed for Fun-n-Stuff following After-Prom via school transportation; buses will depart for OHS by 2:00 a.m. Students will not be permitted to leave prior to this time, nor will they be permitted to leave by any other means except school transportation.

It is recommended that you encourage your child to drive directly home once students return from After-Prom and not to make any stops along the way. If you allow your student to sleep at a friend's home, it is advised that you confirm that this should be his/her only destination and that you review arrangements with the other student's parents.

Prom and After-Prom are expected to be a wonderful experience for your child and we appreciate your cooperation in maintaining a safe and enjoyable evening for the students!
