CITY OF KODIAK FORM OF GOVERNMENT

The City of Kodiak operates under the Council-Manager form of government, which combines the abilities of a professionally-trained, full-time manager with the interested and dedicated services of elected citizens to enhance the safety, livability, and prosperity of the community.

The Mayor, who is elected for a two-year term, presides at Council meetings and certifies passage of ordinances and resolutions passed by the Council.

Two of six Councilmembers are elected annually for three-year terms. The Council appoints the City Manager and Clerk and selects the City's contracted attorney. The Council, by ordinance, enacts legislation, sets policy, adopts the budget, and regulates the fiscal affairs of the City.



DATES OF IMPORTANCE

Voter registration is open throughout the year; however, State election law requires that you be registered to vote 30 days prior to the election to be eligible to vote in that election.

September 14	Early voting will be available
September 28	Last day City of Kodiak absentee ballot requests may be received in the Clerk's Office
October 4	Last day to early vote in person
October 5	ELECTION DAY and the last day to mail a voted absentee ballot
October 12	Must receive absentee ballots by mail by 5 p.m. (ballot envelope must be post-marked no later than October 5, 2021)

WHAT IS NEW? EARLY VOTING

In previous years, the City offered absentee in-person voting for local elections. Absentee voting is <u>verified after</u> Election Day during the Canvass process. This year, early voting will be offered. Early voting is similar to when you go vote at your polling precinct on Election Day. <u>At the time you vote, your eligibility is verified</u> and you are given a ballot to feed into a voting machine.

Early voting ballots are counted and are included in the unofficial tally on Election night. We encourage everyone to take advantage of the option to early vote!

How does early voting work?

- 1. Present your identification and sign the precinct register
- 2. You get a ballot
- 3. Fill out your ballot in a voting booth
- 4. Feed your ballot in the voting machine






WHAT IS NEW? PRECINCT NO. 1 RELOCATION

Once again we have relocated Kodiak No. 1 Precinct <u>from</u> the Harbormaster Building <u>to</u> the Gerald C. Wilson Auditorium Foyer. This is to make sure that everyone can maintain a physical distance of 6 feet to protect yourself, other voters, and election workers.




We encourage everyone to follow the CDC recommendations, the Alaska Department of Health & Social Services advisories, and the recommendations of the Kodiak Emergency Operations Center. These recommendations include, but are not limited to: social distancing, wearing facial coverings, and hand sanitizing.





HOW TO CAST YOUR VOTE



Optical scan voting machines are used in this election. To mark your choice, complete the oval to the left of your selection using the pens provided in the voting booth.

If you should make a mistake, do not make any other marks on your ballot – this may cause your vote not to count. Ask an election worker for assistance in receiving a replacement ballot. By law, you may not receive more than two additional ballots.

If you vote for more candidates in a race than what is indicated in the title of the race, your vote in that race will not count. This is called an **overvote**.

You may choose not to vote on a *Vote for One* race or not to make multiple choices on a *Vote for Two* (or three, or four) race. This is called an *undervote*. The machine will count all properly marked races.


To vote for a qualified **write-in** candidate (whose name is not printed on the ballot), fill in the oval to the left of the blank line provided for a write-in candidate and write the name of the qualified candidate on the line.

ONCE A BALLOT IS SECURED IN THE BALLOT BOX, IT MAY NOT BE RETRIEVED.

Review your choices carefully before inserting your ballot in the machine. A message will be displayed on the screen if you have overvoted any of the races or inserted a blank ballot. However, a message will not be displayed if you have under voted any race. The machine will count all properly marked races. Faint marks may not count so please make sure you completely fill in the oval.

The City has set a goal and achieved having more than six months operating funds. With CARES funds, the City provided much needed funding to Kodiak businesses, day care centers and non profits.

We still have major infrastructure projects to complete: build a new fire hall with community input (major damage was done with the 8.2 earthquake), replacing harbors, maintaining waste water treatment plant operations, repairing roads, Baranof Park improvements and seeking funding for all these projects. As we become less dependent on State and Federal dollars and cost shifting is put upon local municipalities, it is up to Kodiak residents to decide what kind of quality of life they want for their community. It is my priority and challenge to work with other local and state officials to keep our community affordable along with meeting public safety needs, maintaining infrastructure and balancing budgets. We also as a community need to plan for the future of Kodiak in having a viable economy, affordable housing and inviting new industries. 



ARE YOU QUALIFIED TO VOTE?

A person may vote in a City of Kodiak election only if the person:

- is qualified to vote in State elections under AS 15.05.010
- has been a resident of the City for 30 days immediately preceding the election
- is registered to vote in State elections at a residence address within the City at least 30 days before the City election at which the person seeks to vote
- is not disqualified under Article V, §2 of the State Constitution



DIFFERENT OPTIONS TO VOTE

If you are a registered City of Kodiak voter, these are your options to vote this upcoming local municipal election:

Early Voting

Early voting is voting in person before Election day. This is similar to voting at the precinct on Election day. This will be available 21 days before the election.

Absentee By Mail

If you are unable to early vote or go to the precinct on October 5, 2021, you may apply for an absentee ballot by mail. An application form is provided at the back of this voters' pamphlet.

Voting in Person on Election Day

Precinct No. 1 and Precinct No. 2 will be open from 7 a.m. to 8 p.m. on Election Day.

PERSONAL REPRESENTATIVE VOTING IN THE CITY CLERK'S OFFICE

A qualified voter who is unable to go to a polling place to vote because of a disability, may, through a representative, request a personal representative ballot from the City Clerk on any date after the ballots are prepared and available, up to and including election day. If the request for a personal representative ballot is made through a representative, the representative shall sign a register provided by the City Clerk or the City Clerk's authorized representative. The register must include the following information:

- (1) the representative's name
- (2) the representative's residence and mailing address
- (3) the representative's Social Security number, voter number, or date of birth
- (4) the name of the voter on whose behalf the representative is requesting a ballot
- (5) an oath that the representative:
 - (a) is receiving a ballot and voting materials on behalf of the voter
 - (b) will not vote the ballot for the voter
 - (c) will not coerce the voter
 - (d) will not divulge the vote cast by the voter
 - (e) has been notified that unlawful interference with voting is punishable under AS 15.56.030
- (6) the representative's signature

The representative shall deliver the personal representative ballot and other voting materials to the voter as soon as practicable. The voter shall mark the ballot in secret, place the ballot in the secrecy sleeve, and place the secrecy sleeve in the envelope provided. The voter shall provide the information on the envelope that would be required for absentee voting if the voter voted in person. The voter shall sign the voter's certificate in the presence of the representative. The representative shall sign as attesting official and date the voter's signature.

The representative shall deliver the ballot and voter certificate to the City Clerk or the City Clerk's authorized representative no later than 4:30 p.m. on election day.

If a qualified voter's disability precludes the voter from performing any of the above requirements, the representative may perform those requirements, except making the voting decision, on the voter's behalf.

The voter's employer, an agent of the voter's employer, or an officer or agent of the voter's union may not act as a representative for the voter. A candidate for office at an election may not act as a representative for a voter in that election.

ABSENTEE BY MAIL

- 1. When Completing the Application on the Next Page You MUST Provide:
 - Kodiak, Alaska Residence Address Where You Live A complete physical residence address must be included on your application. Your application will not be processed if you leave the residence address blank or if you provide a PO Box, HC No. and Box, PSC Box, Rural Route No., Commercial Address or Mail Stop Address on line 3 of the application.

If your residence has been assigned a street number, provide that number. If not, indicate exactly where you live such as, highway name and milepost number, boat harbor with pier and slip number, subdivision name with lot and block or trailer park name and space number, etc.

- **Proof of Identity** Your identity must be verified. If you have been issued a Social Security Number, an Alaska Driver's License or an Alaska State ID card, you MUST provide at least one number on Line 6 of the application. If you have never been issued one of the identification numbers, you may indicate so by checking the box in Line 6.
- **Date of Birth** Your date of birth is required on the application.
- 2. Are you submitting this application by mail or by fax? If so, and if you did not provide proof of identification at the time of registration, your identity must be verified. If you have not been issued one of the identification numbers listed in Line 6 of the application, your identity may be verified by submitting a copy of one of the following documents:
 - Current and valid photo identification
 - Driver's license
 - State identification card
 - Passport
 - Birth certificate
 - Hunting and Fishing license
- **3.** Have you been convicted of a felony? If so, you may register to vote only if you have been unconditionally discharged. Provide a copy of your discharge papers with this application if available.
