**Addressing and Responding to Intimate Partner Violence and Human Trafficking
in Community Health Centers across North Carolina**

Description: There is substantial research describing the dynamics and effects of intimate partner violence (IPV) and human trafficking (HT) and related co-morbid health and behavioral health outcomes for survivors. Health center staff are in a unique position to initiate conversations with their patients about healthy relationships and violence, offer universal education on the health impact of IPV/HT and promote harm reduction strategies. Building local partnerships with domestic violence or community-based programs will help facilitate warm bi-directional referrals, and promote the short- and long-term safety needs of patients.

This Training of Trainers will begin with a 3.5 hour demonstration of the trauma-informed evidence-based curriculum by FUTURES faculty, on addressing and responding to intimate partner violence (IPV) and human trafficking in community health centers. The curriculum explores: support for staff/capacity building and self-care; dynamics and health impact of DV/HT; the “CUES” evidence-based intervention to initiate conversations with patients; and strategies for partnering with local advocacy programs. Following, the afternoon will focus on attendee readiness as trainers, providing time to ask questions, and discuss strategies. This interactive training curriculum includes small group exercises, group discussions and “pair and share” opportunities, as well as didactic material to appeal to different learner styles. The PowerPoint curriculum and training tools will be available to all participants so attendees can conduct their own similar trainings in partnership with local advocacy staff. An hour lunch will be provided between the morning and afternoon sessions.

Learning Objectives: At the end of this training, participants in attendance will be able to:

1. Identify physical and behavioral health problems associated with IPV and human trafficking (HT).
2. List the benefits of partnering with a local DV agency/community based orgs to promote bi-directional client referrals.
3. Implement a universal education approach to inform patients about healthy relationships and assess for IPV/HT.
4. Know how to conduct a similar training for other community health staff or programs using the FUTURES curriculum.


