In This Report

In 2018, Recovery Specialists were deployed to a patient's bedside 8,881 times, representing a **368% year-over-year increase** compared to 2017. Additionally, there was a 151% increase in deployments in the second half of 2018 compared to the first six months of 2018. This growth coincided with the expansion of the Peer Recovery Program into four new hospitals in 2018, bringing the total number of participating hospitals to 19. The program also expanded to serve inpatient units in addition to emergency departments.

The 2018 Yearly Report presents information on the number of deployments, the population served, and bedside outcomes. The Appendix contains data stratified by hospital and county. The information included in this report is subject to change.


Program Background

The RWJBarnabas Health (RWJBH) Institute for Prevention and Recovery's (IFPR) Peer Recovery Program (PRP) provides recovery support services for individuals with substance use disorder identified by the hospital. The PRP employs Recovery Specialists who are in long-term recovery from substance use disorder and provide bedside intervention and peer recovery support and clinically-trained Patient Navigators who link individuals to the appropriate level of care.

The PRP serves patients 24 hours a day, 7 days per week in 19 RWJBH-affiliated and non-RWJBH hospitals throughout Essex, Hudson, Middlesex, Monmouth, Ocean, Somerset, and Union Counties. A list of hospitals is included in the Appendix.


Deployment Summary

Recovery Specialists were deployed to a patient's bedside **8,881 times** in 2018. There were 1,898 deployments in 2017 and 720 deployments in 2016. Hospital- and county-specific deployment data is available in the Appendix.



Population Served

Of the 8,881 patients subject to deployment, nearly one-third received at least one dose of naloxone prior to bedside intervention. Approximately two-thirds of the patient population was male. Most patients were between the ages of 26-44 (43.2%) and 45-64 (39.0%). The majority (58.1%) of patients were white, 23.0% were black, and 11.0% were Hispanic. Additionally, 56% of patients were covered by Medicaid or were uninsured. Throughout this report, "Unknown" consists of responses of "do not know" or "refused" and missing data.







Bedside Outcomes

The Institute for Prevention and Recovery measures success through the acceptance of recovery support services. These services are anything that helps an individual move through the Substance Abuse and Mental Health Services Administration's (SAMHSA) working definition of recovery, emphasizing the process of change through which individuals improve their health and wellness, live self-directed lives and strive to reach their full potential.

In 2018, 638 patients were not available for services (i.e., patient left against medical advice, incoherent, incarcerated, deceased, etc.). **88.5%** of patients available for services accepted bedside deployment by a Recovery Specialist. **94.9%** of the patients who accepted bedside deployment also accepted some form of recovery support services.


