

RESOLUTION REGARDING HOME RULE

- WHEREAS: The State of Georgia Constitution grants the State sole authority to define district boundary maps (Paragraph VI. Special districts, subparagraph c); and
- WHEREAS: Cobb Board of Commissioner members Lisa Cupid (Chair), Monique Sheffield, and Jerica Richardson have illegally voted to ignore the state law passed by the Georgia General Assembly and signed by the Governor regarding redistricting by declaring "home rule"; and
- WHEREAS: Lisa Cupid, Monique Sheffield, and Jerica Richardson of the Cobb County Board of Commissioners have broken their oath of office by not upholding the Georgia Constitution and by declaring "home rule" to utilize a new district map designed by these members of the Cobb Board of Commissioners; and
- WHEREAS: JoAnn Birrell and Keli Gambrill of the Cobb County Board of Commissioners have argued and fought back against this illegal use of "home rule" and in so doing have also defended the Georgia Constitution and State law.

NOW THEREFORE BE IT RESOLVED, the Georgia Constitution and the redistricting map passed by the Georgia State Assembly and signed by Governor Kemp must be accepted by the entire Cobb County Board of Commissioners; and

BE IT FURTHER RESOLVED, Lisa Cupid, Monique Sheffield, and Jerica Richardson of the Cobb County Board of Commissioners must immediately honor their oath of office and recommit themselves to obeying the Georgia Constitution and the laws of the state of Georgia or immediately resign from the Board; and

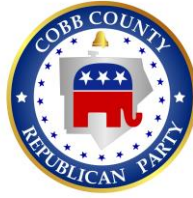

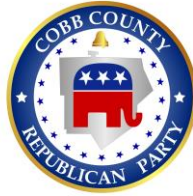


RESOLUTION REGARDING RESTRICTING FREEDOMS OF AMERICAN CITIZENS

WHEREAS: The Federal government, led by Biden, his administration, and Democrats who are in control of two of the three branches of government, are removing the rights and freedoms given to us by our Creator, the Constitution, and the Bill of Rights including, but not limited to the following:

NOW THEREFORE BE IT RESOLVED, this Resolution requires that all elected officials, and especially state and federal elected officials immediately restore all rights given to American citizens by our Creator, the US Constitution, and the Bill of Rights that have been restricted, and then to firmly protect any and all said rights in the future.



RESOLUTION REGARDING ELECTION INTEGRITY

WHEREAS: Clear evidence of fraud, errors, mistakes, etc. have been accumulated since the 2020 and 2022 elections. Consequently, a large percentage of voters in the state of Georgia still have distrust of the results of those elections; and

WHEREAS: QR codes on ballots are the sole source for ballot tallies on all in-person voting. For this reason QR codes are not trusted and appear to be illegal; and

WHEREAS: Voting machines currently being used are not trusted by a significant percentage of the Georgia voters. Drop-off ballot boxes are not secure. Voter rolls are not accurate and are not reviewed regularly. Advanced in-person voting is extended beyond a reasonable timeframe. Mail-in ballots not considered Absentee ballots are highly suspect; and

WHEREAS: There is an effort to move toward Ranked Choice voting. The highest vote getter sometimes loses an election they otherwise would have won. The more candidates on any ballot decreases the chances that the highest vote getter would eventually win with the Ranked Choice voting process.

NOW THEREFORE BE IT RESOLVED, voting machines are to be removed and a hand-marked paper ballot system is to be implemented immediately. Ballot drop boxes are to be discarded permanently. Rules for maintaining voter rolls need to be reviewed and the voter rolls themselves must be cleaned up on an on-going basis; and

BE IT FURTHER RESOLVED, the use of QR codes for ballot tallying are illegal and should not be used. Cobb County Board of Elections should immediately stop using QR codes on all ballots; and

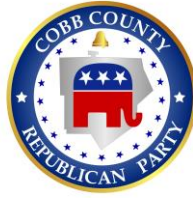
BE IT FURTHER RESOLVED, The State Election Board must seek an opinion in Federal Court whether the Dominion Voting Machine contract is valid or voidable; and

BE IT FURTHER RESOLVED, voting should be done in-person on election day only or by official absentee ballot. Approved absentee ballots should be available to every authorized voter who legally requests an absentee ballot and has good reason to request said ballot. Mail in ballots not considered Absentee ballots are to be eliminated; and

BE IT FURTHER RESOLVED, Ranked Choice Election processes are not to be allowed in Georgia; and

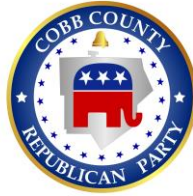

RESOLUTION DENOUNCING THE USE OF DEI AND CRT IN COBB COUNTY

WHEREAS: The Republican Party is in total support of the vision of Dr. Martin Luther King, Jr. for America to be places where every person “will NOT be judged by the color of their skin but by the content of their character”; and

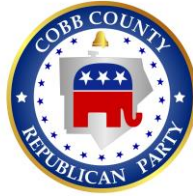
WHEREAS: Contrary to what the Democrat majority commissioners and their meetings with Chrysalis Labs attest, the United States of America, the state of Georgia, and Cobb County are not racist, with Georgia number three (3) in the US with the largest black population, ranking 9th across the nation in the US Census Bureau Diversity Index, with Cobb County having 29% (US 13%) black population and 61% (US 75%) white population becoming more diverse than ever; and

WHEREAS: Unconstitutional Diversity, Equity, Inclusion (DEI) and Critical Race Theory (CRT) go hand-in-hand, and are contrary to the Civil Rights Act. Quoting Florida Republican Governor Ron DeSantis with the passage of Florida’s recent ban on CRT which teaches that *"the theory that racism is not merely the product of prejudice, but that racism is embedded in American society and its legal systems in order to uphold the supremacy of white persons"*; and

WHEREAS: At least 35 states have passed or considered legislation prohibiting teaching Critical Race Theory (CRT) in classrooms (with DEI another version of CRT); and the Cobb County Board of Education issued a resolution banning CRT from the classroom; and

WHEREAS: Recent Open Record Requests (ORR’s) by the community that elected her to office, as well as articles from “South Cobb News”, revealed that Board of Commissioners Chair Lisa Cupid and her fellow Democrat Commissioners have been holding meetings that included such consultants as Chrysalis Labs and Accenture, both pushing DEI, without including the two Republican Commissioners which allegedly is in conflict with the Open Meetings Act; and

WHEREAS: Cobb County is a highly diverse county with diverse neighborhoods based on the free market in agreement with the Civil Rights Act, the Bill of Rights, and both the United States and Georgia Constitutions offering housing based on free choice and affordability with no need to state the divisive and inaccurate accusation from Chrysalis Lab that *“Cobb County, like suburban communities across the nation, remains stubbornly segregated and inequitable along racial lines.”*



NOW THEREFORE BE IT RESOLVED by the Convention of the Cobb Republican Party, we urge the Georgia Attorney General to take appropriate legal action against the three Democrat members of the Cobb County Board of Commissioners for their violation of the Open Meetings Act, and for their abuse of the US Constitution, the Georgia Constitution, and the Civil Rights Act.

BE IT FURTHER RESOLVED, the Cobb County Republican Party hereby condemns the actions of the Democrat members of the Cobb County Board of Commissioners for their unconstitutional efforts to foster what is arguably surreptitious racism by using outside consultants that advance unconstitutional Diversity, Equity, and Inclusion through all processes in Cobb County Government by using Cobb citizen tax dollars to do so.
