This is a worksheet that will assist WE THE PEOPLE in preparing your Will.

If you have any questions, refer to the Will Overview.

If you are unsure about any aspect of your estate or who you want to inherit your estate, you should seek competent, independent legal advice from an attorney.

TERMINOLOGY USED IN THIS WORKBOOK AND IN YOUR WILL:

YOUR BENEFICIARY(IES): Your BENEFICIARY(IES) is the person or persons you are leaving your estate to when you die. You can pick ALTERNATE BENEFICIARIES if your BENEFICIARIES die before you do. A Beneficiary can be an Executor as well.

DISINHERITING (Optional): Is there any relative you specifically DO NOT WANT to receive anything from your estate when you die?

SPECIAL GIFTS (Optional): You can choose to leave your beneficiaries Special Gifts after you die. The Special Gifts are distributed from your estate first, and then the remainder of your estate is distributed to your beneficiaries as you direct. You can list any individuals or organizations that you wish to receive gifts from your estate after you die. [for example: house, land, jewelry, money, antiques, cars, pets, dolls, baseball cards etc.]

THE EXECUTOR OF YOUR ESTATE: Your EXECUTOR is the person or persons who will serve as your personal representative and the person or persons who will distribute your estate according to your wishes after you die. You can pick an ALTERNATE EXECUTOR if your EXECUTOR is unwilling or unable to serve as your personal representative. Your Executor can be one of your Beneficiaries.

THE GUARDIAN OF YOUR MINOR CHILDREN UNDER THE AGE OF 18: applies ONLY if you have children under the age of 18. Your GUARDIAN is the person or people who you want to raise your minor children if you and your spouse die. You can pick an ALTERNATE GUARDIAN if your GUARDIAN is unwilling or unable to serve as GUARDIAN for your children under the age of 18.

THE CUSTODIAN OF ANY BENEFICIARY(IES) UNDER THE AGE OF 21: applies ONLY if you have beneficiaries under the age of 21. If any of your beneficiaries are under the age of 21 at the time of your death, you will name an adult over the age of 21 who will be the CUSTODIAN of the Beneficiary(ies) share of the estate. This is the person who will manage your Beneficiaries' inheritances.
