VIII Finance Report-David Wilkosz

- Reviewed YTD 2020-2021 (2nd quarter)
 - People are minding expenses and sacrificing to keep on budget
 - We are still negative
 - Short \$160,000 revenue
 - Membership & COVID taking a toll
 - We spent less money than last year, but people are not giving as much
 - Have not made principal payments on LCEF loan, only interest
 - Have not been able to get DCE/Deaconess or office help positions
 - We anticipate 100% of PPP loan to be forgiven
 - 3 Ruth Lane houses, if sold, would definitely help us meet LCEF loan payments
 - Are working on subdividing the 3 properties, delayed due to COVID
 - In contracts with buyers
 - All proceeds will go to paying off LCEF loan
