Please join us for a new training series brought to you by the 3 County Continuum of Care and the Western Mass Network. Presented by Racial Equity Partners (REP), the series offers 5 online sessions, each exploring a topic that will deepen participants' understanding on the impact of structural racism. The goal of the sessions is for attendees to gain a better understanding of the history of race and white supremacy, the impact of racial trauma, racial disparities in homelessness - and the importance and value of people with lived experience to affect systems change; and discuss their ideas for strategies to address racial inequities and to strengthen our relationship with people with lived experience.

### **Defining Lived Experience**

This Session will review the concept of "lived experience" and "lived expertise" and share how organizations work to center and integrate PLE into decision making, advocacy and systems change. We'll also discuss fundamental knowledge about organizations and federal housing programs (construct, acronyms, language) - and the different ways to engage with them – from services to advocacy - in the work to end homelessness.

### **The History of White Supremacy and Becoming Antiracist**

Session will provide some history on race and white supremacy in America, discuss white privilege and how it has advantaged and disadvantaged groups and strategies for becoming antiracist.

**Understanding and Overcoming Trauma**

Session will introduce the trauma-informed care framework to complement the work of racial equity. Attendees will learn the connection between racism and trauma and intergenerational trauma; they will also learn how to respond both to others and to self- in order to move through the experience of trauma towards healing. Trauma-resiliency and self-care will be highlighted, necessary to fuel the work of racial equity and inclusion.
