**Dixie Fire West Zone**: Firefighters continue to make progress in building and reinforcing containment lines. Spots inside the burn area continue to smolder but pose no threat to the containment line. Firefighters used cooler temperatures yesterday and last night to build containment lines in the northern part of the fire, North of Highway 44.

Tactical patrol, mop-up, and calls for service continue in the Lake Almanor, Westwood, and Janesville areas. The west portion of the fire continues to be mopped up and no reports of spot fires over the containment line.

Temperatures reached the mid-80's today with winds of 10-15 mph. Humidity was slightly lower today at 12-20%. Fuels will continue to dry out tonight and through the week. Because of this weather, the rate of spread in uncontained areas will be moderate. The spotting potential will also increase to the weather.

#### **Current Situation**

Residents are urged to stay vigilant to changing weather and fire behavior. Smoke will be seen in the fire areas and surrounding communities for many days. Damage assessment is ongoing, and the threatened structures count may change depending on the fire status.

\*A firefighter assigned to the Dixie incident passed away, due to an illness on September 2.

**Dixie Fire East Zone:** Operational Update Saturday Evening, September 12, 2021 Today on the East Zone of the Dixie Fire, firefighters worked to secure direct line construction in the Devil's Punchbowl area, to hold and improve dozer and handline from Lake Davis to Clover Valley, and to secure dozer and handline to keep fire from spreading further south into Dixie Valley, as well as south towards Clover Valley and Portola.

East of Milford, crews worked to maintain direct and indirect containment lines on the NW flanks of the fire south from Highway 395 to prevent fire from again impacting Milford and Highway 395. Firefighters reinforced dozer line in Dotta Canyon to the Sugar Fire scar as an alternate contingency line and worked to improve Road 177 and Beckwourth-Genesee Road as secondary control lines. Structure protection is in place within Genesee, Dixie Valley, Lake Davis area, Milford, and Taylorsville.

#### SHASTA COUNTY EVACUATION ORDERS

- Zones 9-A and B are forested areas, 9-A is an area east of Highway 89 just south of Hat Creek. It extends to the Shasta/Lassen County line.
   Zone 9-B extends from just east of Cinder Butte on the western edge to the Lassen/Shasta County line and north of Bald Mountain.
- all residents in Old Station Zone SCU-003. This includes the area east of Highway 89 just north of Black Angus Lane, and north to the intersection of Highway 89 at Doty Road following Bidwell Road east to the Pacific Crest Trail.
- Residents of all roads between the Lassen National Park entrance and the Bridge Campground.
- Any residences on Highway 44 from the Lassen County line.
- Hat Creek Rim east to the Shasta County Line and south of SR-44

The Bizz Johnson National Recreation Trail near Susanville, as the Bureau of **Bureau of Land** Land Management has rescinded a temporary emergency closure associated Management with the Dixie Fire. Also reopened are the Hobo Camp and Devil's Corral trailheads and all other BLM-managed lands that were affected by the emergency closure that went into effect Aug. 16. This includes BLM-managed lands south of California Highway 36, west of U. S. 395, and north and east of the Lassen National Forest boundary. Lassen Evacuee The Lassen National Forest has the Christine Campground on Eagle Lake **Campsites** Ranger District and the Bridge Campground on the Hat Creek Ranger District available for evacuees. Evacuee's primary residence must be under mandatory evacuation and need to check in with the campsite's hosts. Before you go, make sure the campgrounds are not under any evacuation warnings.
