### Ed Shemelya:

Ed Shemelya is the National Coordinator for National Marijuana Initiative (NMI). The NMI strives to dispel misconceptions about marijuana and raise awareness of issues surrounding the drug, so that citizens and policymakers can make well-informed choices regarding marijuana use and regulations.



#### Jennifer Cifaldi:

Jennifer Cifaldi is the Illinois Traffic Safety Resource Prosecutor and is employed by the University of Illinois at Springfield through a grant from the Illinois Dept. of Transportation. Prior to that, Jennifer served as an Assistant State's Attorney in Adams County, Illinois prosecuting traffic cases at both the felony and misdemeanor level. Jennifer developed a DUI No-Refusal search warrant model that has now been adopted as the standard for Law Enforcement agencies and Prosecutor Offices across Illinois.

Aaron Weiner, PhD, ABPP is a board-certified Psychologist and addiction specialist, and speaks nationally on the topics of addiction, behavioral health, and the impact of drug policy on public health. Dan Stafiej:

Officer Dan Stafiej is a fifteen-year law enforcement veteran, a drug recognition expert (DRE) and instructor with the village of Carol Stream Police Department's Traffic Safety & Investigation Unit. Officer Stafiej's current duties include intoxicated motorist interdiction, crash investigation, traffic enforcement, public education, and law enforcement training.
