## All Dressed in White Bridal Show CONTRACT TERMS and CONDITIONS

The exhibitor agrees to abide by all rules and regulations adopted by Coastal Publications Ltd. producer of All Dressed in White Bridal Show and the venue which show is held, collectively ("Management") and agrees that "Management" shall have final decision in adopting any rule or regulation deemed necessary prior to, during and after the show. The exhibitor agrees observe all union contracts and labor relations agreements in force as well as any agreements between "Management" and the venue in which the show is held.

To decorate within the booth dimensions appropriate items and materials, related to the products or services normally sold by exhibitor. Provide sufficient and qualified staff to represent their display during the hours the All Dressed in White Bridal Show is open public. exhibitor staff must operate within the booth dimensions.

In the event that Exhibitor fails to pay balances by agreed dates, deposits and/or fees paid shall be forfeited and Exhibit space reservation cancelled. This Agreement cannot be cancelled within 60 days of the event date without forfeiting all previously paid fees and deposits. If cancelled 60 days or more advance of the event only the \$200 deposit is non refundable.

All exhibits must remain within the booth dimensions. Exhibitors may not attach any materials or displays of kind to walls, doors, ceilings and/or structural supports of the facility in which show is held. No component of any display facing neighboring booths shall be left unfinished.

Provide one mandatory gift to be included for your booth prize draw that will have a minimum retail value of \$50 and shall not in any way tied purchase requirement. If the Exhibitor agrees to participate on the All Dressed White Bridal Show sponsorship prizes, the exhibitor agrees to honor these prizes.

NOT TO DISTRIBUTE OR DISPLAY ANY SIGNS, MATERIALS PRODUCTS, other than goods, products and signs normally offered by the Exhibitor to public in their place of business.

No smoking will be allowed in the Exhibit Hall. Absolutely no helium balloons other hazardous items are permitted in the Exhibit Hall.

Samples: all Exhibitors distributing food samples that require handling, cooking and or preparation prior to or during the show must have all certificates and approvals from the Health Authority and must adhere to rules and regulations set forth by the Health Authority. Food and beverage samples are permitted for distribution to attendees but all must adhere to food and beverage sampling regulations and maximum samples size limitation set forth by the Facility as described in the exhibitor manual. Selling food and beverage items for consumption at show is not permitted without expressed permission from Facility.

The Exhibitor agrees to remove all exhibit merchandise from the building by final move out time, and in failure do so, will pay for such additional costs as may be incurred.

The "Management" shall not under any circumstances whatsoever be liable or responsible for (a) any loss, damage, theft of destruction whatsoever or how so ever caused to any goods, equipment or and other property belongings to the Exhibitor or for which the Exhibitor is responsible (b) any damage or injury suffered by the Exhibitor, Exhibitor's employees, agents, contractors, or by any other person (c) any loss, damage, injury or cost what so ever suffered by the Exhibitor by reason of any change in the date, time or place of the Show of the abandonment thereof. Essential Information: Liability Insurance Policy We strongly advise that you obtain your own event liability insurance policy. It is recommended to have coverage of at least \$1 million, which can be issued specifically for the duration of your participation in the event. If your organization already has insurance, you may use that provider. Should you choose to secure insurance for your protection, please provide us with a copy of the insurance certificate.

The exhibitor accepts all risks associated with the use of the exhibit space. The exhibitor shall not make any claim or demand or take any legal action, whatsoever against "Management, the show sponsors or the facility in which the show is held, for loss, damage or injury howsoever caused, to the exhibitor, its officers, employees, agents or their property. Also, the exhibitor agrees to indemnify and hold harmless "Management", show sponsors and the facility, their respective officers, agents and employees, against all claims, costs and charges of every aspect resulting from the occupancy of the exhibit space for personal injuries, death, property damages or other damage sustained by the exhibitor or its officers, agents, employees, or those for whom in law they are responsible,, or "Management" or visitor to the show.

In the event that the facility in which the show is to be held or is held is destroyed or becomes unavailable for occupancy, for reasons beyond the control of "Management" and sponsors, or if for any reason "Management" is unable to permit the exhibitor to occupy the facility or the space, or if the show is cancelled or curtailed, "Management and sponsors will not be responsible for any loss of business, loss of profits, damage or expense of whatever nature that the exhibitor ay suffer. The reasons listed include, but are not limited to, such reasons as:: casualty, explosion, fire lightning, earthquake or any other acts of God, acts of public enemies, strike, lockout or boycott.

With the best interest of the show on the mind of all circumstances not covered by this contract will be subject to the decision of "Management". "Management" will have full discretion in the interpretation of all terms, conditions and rules herein and will make any amendment thereto governing the show. Any agreements between Exhibitor and their suppliers is the sole responsibility of the Exhibitor.

The date of the show and the venue are subject to change.

Required deposit must be paid upon receipt of invoice in order to secure your booth space in the show. All applications will be processed on a first come first serve basis.

In view of the selection, exclusive nature and the unique tie-ins involved, I fully understand and agree that this contract is firm and cannot be cancelled. Further, I agree that I shall waive any rights whatsoever, based on performance or otherwise, with regard to non-payment by me, of sums that be due and payable under this agreement.
