Families will submit their completed parent volunteer form confirming hours served by Friday, April 30, 2027 or pay the \$1000 alternative option by April 30, 2027. _____(parent initial)
3. We understand that students may not begin classes until all financial obligations are met, all paperwork is complete, and all required forms have been returned. _____(parent initial)
4. We agree that the school will provide educational services for stated tuition, fees and other charges; that payment is due according to the financial agreement filled out at the time of registration; and that failure to fulfill financial obligations will result in suspension of services by the school. Specifically, students who have outstanding tuition and fees will not be allowed to take semester exams until accounts are paid and brought up to date. _____(parent initial)
5. We understand that if our student is not a senior, we must re-register our student for the 2027-2028 academic year prior to January 31, 2027. If we choose to register our student after January 31, 2027, we understand that we will pay a higher registration fee. _____(parent initial)
6. **THE BRUIN SPIRIT FUNDRAISER:** We understand that **each enrolled SPSV student is required to participate in the Bruin Spirit Fundraiser**, the school's primary community-wide fundraising effort that supports tuition assistance, student programs, and the mission of SPSV. Each student is responsible for raising the required funds by seeking donations from supporters, whose contributions will be entered into the raffle through the school's digital fundraising platform, or by making a direct donation equal to the required fundraising goal. The required fundraising goal for the 2026-2027 school year is **\$500 per student**. If the required fundraising amount is not met through donations, we understand and agree that the remaining balance will be charged to our **FACTS** tuition account beginning in January 2027 and will not qualify as a charitable tax-deductible contribution. _____(parent initial)
