I, \_\_\_\_\_, hereby pledge to hold safety as the highest priority on the 2019 Tri-County tractor ride. The safety of my fellow riders and public traveling on the route is of the utmost importance. I pledge to obey the following rules:

1. Hold a valid driver's license. We will be checking them prior to the ride.
2. Follow all traffic laws.
3. Only use cell phones in case of emergency.
4. Riders will sit on securely mounted seats. No riders on fenders or draw bar.
5. Maintain proper speed of the group.
6. Depart at my assigned designated time.
7. Riders on trailers must sit in permanently attached seats
8. Post SMV sign.
9. Follow the designated route.
10. Abide by the decisions of the Ride Management Team, based on the National Weather Service, in the event of inclement weather.
11. Good operating brakes are required.
12. I agree to operate machine in a safe and respectful manner.
13. Tractor operators are responsible for the safety of riders on their machine or towed trailer or wagon.
14. I understand violating these rules will result in the denial of all future applications. Repetitive violators will be asked to leave the ride per the Ride Management Team.

I, for myself and my personal representatives, heirs, successors, and assigns, in consideration for being involved the Tri-County Tractor Ride, hereby hold harmless, release, indemnify and discharge from liability all Ride Management Team members and any sponsors from all liability, claims judgments, demands, controversies, agreements, damages, actions, and causes of action whatsoever, arising out of or in any way related to me participation in the event or any related activities whether in law or equity, no matter what the cause or nature, and I further waive any claim that I might state or assert against any of the released parties which I have or may have at any time arising out of my association with, travel to or from, or participation in the event, or in any other way related to or resulting from the event. I acknowledge that I have full knowledge of the risks involved in this event and am physically able and sufficiently trained to participate in this event. I understand the Ride Management Team reserves the right to limit the number of tractors in the ride in order to control traffic and other administrative tasks. I give my permission for the free use of my name and pictures in any broadcast, telecast, or print media account of this event.
