

What if an employee refuses to come back to work?

There are some concerns that employees may not want to come back to work because their unemployment, with the additional \$600, is higher than their earned income. If an employer thinks an employee is refusing work without good cause, the employer should go to this site and complete the online form: <https://secure.ifs.ohio.gov/covid-19-fraud/> Upon receipt of the form, ODJFS “will review the necessary files and records in light of the information you have provided to determine the most appropriate action.”
