Ms. Simmons was nominated by the Hillsborough County Bar Association Young Lawyers Division and the Hillsborough Association of Women Lawyers.

Since the start of her practice at Hill Ward Henderson in 2013, Ms. Simmons has proven her dedication and passion to serving the community through pro bono work in leadership and service roles inside and outside of the firm. Also in 2018, Ms. Simmons donated her legal services on a pro bono basis to complete the pending merger of Trinity Café and Feeding Tampa Bay, which will unify and strengthen two nonprofits working to alleviate hunger in the Tampa Bay region. In her role as the co-chair for the law firm subcommittee of the 13th Judicial Circuit Pro Bono Committee, Ms. Simmons has advocated for increased pro bono participation and coordinated pro bono summits and presentations for law firms throughout Tampa.

In addition to her pro bono service outside of the firm, Ms. Simmons has served as the pro bono coordinator for Hill Ward Henderson since 2015. In this role, she encourages firm-wide and individual attorney participation in various pro bono programs, and assists with training for pro bono projects.
