#### **Menu Guidelines:**

# **Courses and Prix-Fixe:**

- Lunches must be at least two courses at either \$10 or \$15.
- Dinners must be at least three courses (appetizer, entrée, dessert) at \$19, \$29 or \$39.
- Local ingredients and local beverages are encouraged.
- All marketing materials must state that the price per guest includes all courses, but it does not include alcoholic beverages, tax or gratuity.

#### **Lunch Participation:**

- Restaurants may opt to offer a minimum two-course lunch menu.
- Restaurants can choose one of two price points: \$10 or \$15. At least one option must be offered for each course, but multiple options are welcome.
- Offering lunch is not mandatory. Restaurants may offer a lunch menu, but not a dinner menu.

### **Dinner Participation:**

- Develop a \$19, \$29 or \$39 fixed-price menu.
- Each course must have at least one option, but feel free to offer multiple choices per course. For example, you may offer choices for two appetizers, four entrees, and three desserts. The diner chooses one from each category to complete their meal. The price is fixed regardless of their choice.
