Dear Friends and Colleagues,

Greetings and Happy Fall!

We are pleased to present you with our Fall/Winter 2022 newsletter, and hope you enjoy the new resources and make time to connect with us at upcoming events.

I usually dedicate this space to a specific health equity topic. This time I thought to encourage reflection on the state of the health equity movement.

It has been almost three years since the onset of the pandemic, which has disproportionately affected communities that have been marginalized or experience other kinds of vulnerability and disadvantage. While progress has been made, social discrimination is still rampant in our cities and countries with recent policy setbacks for gender equity and LGBTQI+ rights. Systemic racism continues to be an issue in many institutions and systems. Climate change is increasingly affecting under-resourced communities. Yet, health equity does not seem to be any more in the news as at the beginning of the pandemic, something that continues to be important to build broader coalitions.

This is a time for reflection on the state of health equity in our own organizations and the communities we serve or belong to. What has worked so far? What should be improved? What kinds of resources and

partnerships should be mobilized to further the movement and continue to effectively address health, racial and social inequities both in the U.S. and globally? Who else should we engage both from the public and private sectors? How do we mainstream community engagement in health equity research and practice? These questions are being discussed in our networks at [Health Equity Initiative](#) and hope they are at the forefront of your efforts in your organizations and communities.

In the meantime, I want to thank you all for your hard work and dedication to reducing health inequities. Thank you for being part of our community, supporting our efforts, collaborating with us, and following us.

We hope that the year ahead will bring an increased investment on achieving health, racial, and social equity in all of our communities. We should continue to fight for a better tomorrow.

Farewell to HEI Summer 2022 Intern!



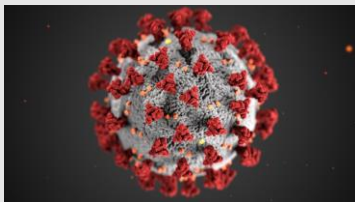
