Several AgeOptions staff and Board of Directors members attended Aging in America, the annual American Society on Aging (ASA) conference, with some making presentations on a variety of topics. Jonathan Lavin, AgeOptions president and CEO, was a co-chair of the conference, which took place March 20-24 in Chicago.

Aging in America, the largest conference on aging in the nation, is an opportunity for professionals to learn from their peers and gain new perspectives, according to Rob Mapes, AgeOptions director of Program and Community Support. "The field of aging is getting more complex by the day," he said. "We must adapt and respond to changing financial models and an increasing and more diverse older population while using new technology for the best impact."
