Former Public Policy Chair Mary Ellen Scribner continues to inspire and inform us. Thanks to her for helping compile the current issues. Now that our Texas Legislature is on "interim" between sessions, we cannot rest from efforts to understand and follow politics that are relevant to the mission of AAUW. As a founding partner of the <u>ERA Coalition's National Strategy Task Force</u>, AAUW will continue to call on Congress and the Administration to affirm the Equal Rights Amendment. Together, with your membership, support, and continued advocacy, we can advance policies that continue to break down educational and economic barriers for women.

Did anyone participate in the **Bigger Than Roe – Women's March** on January 20, 2024? Abortion is an issue around the country, influencing legislation, caucuses and primaries. Rebecca Todd Peters is a feminist and Christian social ethicist who serves as a professor of Religious Studies at Elon University. Peters' scholarship focuses on questions related to economics, the environmental crisis, globalization, poverty and women's access to reproductive health care.

In the field of EDUCATION, there are continuing efforts to OPPOSE:

### 1. Chaplains in Public Schools - TFN (Texas Freedom Network)

Per SB763, public school districts are required to vote between September 1, 2023, and March 1, 2024, on whether they will allow unregulated chaplains to provide services to students. Whether you are a parent, current or retired educator, or community member, you can advocate in your community and help prevent this. Our toolkit has background information, talking points, tips for testifying at your school board meeting, and more. ### 2. Bans on Diversity, Equity, and Inclusion – more in Austin Chronicle

As the last legislative session's fruits take effect this January, public universities are being forced to slash efforts to increase diversity. Sen. Brandon Creighton's Senate Bill 17, which bans diversity, equity, and inclusion (DEI) programs, passed along party lines with Republican supporters arguing that such programs are "exclusive" and have been "weaponized to compel speech instead of protecting free speech," according to Creighton. "There is no logic in the belief that you increase diversity by removing the policies and offices that work to promote it," said Sen. Borris Miles, D-Houston, upon SB 17's passing. The ban blocks public institutions of higher education from having any office promoting policies or procedures or influencing hiring or employment practices "with respect to race, sex, color, or ethnicity." (Even UT OLLI had to change name of the "Diversity Committee" to OLLI Community Outreach Committee.)

### And we can SUPPORT:

#### 1. CLIMATE ACTION:

Tell U.S. Congress to Advance Climate Policies – per Church and Society of the United Methodist Church. Specifically, we urge Congress to advance climate justice by:

- Funding the United States' fair share of contributions to international efforts that support climate vulnerable countries;
- Opposing riders that would weaken or defund provisions of the Inflation Reduction Act or the ability of federal agencies to carry out climate initiatives; and
- Prioritizing a just transition to a cleaner, healthier energy economy including funding for the Environmental Protection Agency to advance environmental justice and protect human health.


Her family will announce her memorial service as soon as it's known.



In January, the Banned Book Club of Red Wine & Blue held its bimonthly Zoom meeting at which *The Kite Runner*, a novel by Afghan-American author Khaled Hosseini, was discussed. An English teacher presented her way of teaching it and then there were three breakout sessions. The sessions I attended very lively and interesting, with points of view from different age groups, parts of the country, occupations, etc. The teacher, quite young herself, had expressed surprise at coming to the realization that her students weren't born at the time of the 9/11 incident and most knew very little or nothing about it. I was pleased to see Resa Dunn and Anita Knight (hope I didn't miss anyone else) in attendance. I am already looking forward to the next meeting in March at which *Caste* by Isabel Wilkerson will be discussed.



"You are invited to the **virtual** March Banned Book Club as the group reads and explores *Caste* by Isabel Wilkerson. The book explores the pervasive influence of a caste system in societies, transcending factors like race and class. Wilkerson draws parallels between caste systems in America, India, and Nazi Germany, identifying eight pillars that underlie such systems. Through compelling stories, including those of Martin Luther King Jr., Satchel Paige, and others, she illustrates how caste affects people's lives daily. The book examines the historical connections between American racial systems and Nazi ideologies. Wilkerson also delves into the health and cultural implications of caste, ultimately suggesting ways for America to move beyond divisive human divisions towards a more hopeful shared humanity."
