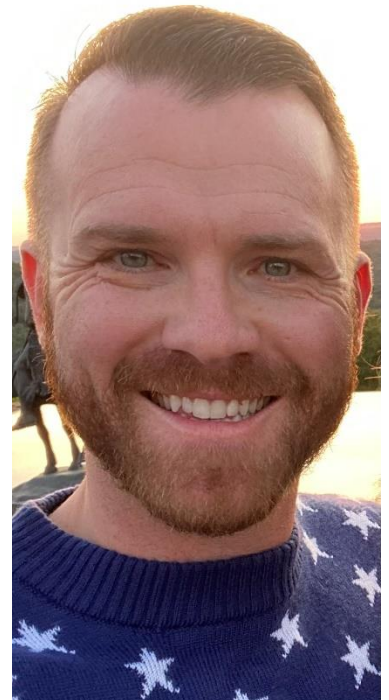
Thad Snider, Kansas Voting System Integrity Investigator, to Speak in Wichita on Thursday, February 24th

If you thought that blatant election-cheating could happen only in Arizona, Georgia, Wisconsin, or Pennsylvania, then sadly, you are in for a rude awakening. In many areas, such as accuracy of voter registration lists, Kansas ranks among the worst in the nation, with a Heritage Score of 63%, or a letter grade of "D". In absentee ballot management, Kansas gets 48%, or a letter grade of "F". In verification of citizenship, Kansas gets the lowest possible score, 0%, another "F".

However, not every flaw can be blamed on Kansas Election officers. In rating Kansas election litigation procedures, the Heritage Score is also the lowest possible score, of 0%. Kansas election litigation procedures are in a horrible, rotten, condition, and are entirely the responsibility of the Kansas Legislature.

But, **Thad Snider**, of Lenexa, brings a lot more than a bad Kansas Report Card. Instead, he brings actual, irrefutable, damning, evidence of what he has found, ...not just system flaws, or hypothetical possibilities, but rather what has already happened in Kansas in the 2020 and 2021 elections. His information will shock anyone who cares about democracy and fair elections.



The only thing more shocking than what **Thad Snider** will show you, is the evil tendency of the Kansas election bureaucrats and other people in charge – including some courts and judges, who worry more about impeding those who want to expose election fraud in Kansas, than they are in solving the problem.

Even the Kansas Legislature, has so far given an anemic response to the outrageous revelation's brought fourth by **Thad Snider** and others like him.

Thad will stand for questions from the public following his presentation at the February KRA meeting.
