You must receive approval and final confirmation from the Chamber of Commerce via email to confirm your booking.

We are offering space at Centennial Park in Hot Springs, SD as well as restricted space for Food Vendors only at the Hot Springs Municipal Airport. The most traffic will be seen at the Airport, however that location is only utilized for a few hours during the morning air activities. The main Vendor area is at Centennial Park in downtown Hot Springs.

Please be advised that aerial related activities are weather permitting.

CENTENNIAL PARK

Friday, August 28, 2026 - Noon to 7 pm
Saturday, August 29, 2026 - 9 am to 6 pm

Centennial Park booth space is 10' x 10' and includes space only. We will have live music in the park on Friday night. There will be security in the park overnight. On Saturday, we will have giant inflatables on the north side of the park that are free to the public. CENTENNIAL PARK FOOD VENDORS must have a current City of Hot Springs Food Vendor License to participate. Food Vendors have the option of opening at 8 am on Saturday morning, due to the need for breakfast availability for the festival goers. Food Vendors also have the option of being in Centennial Park on Saturday evening for the Night Glow.

Centennial Park Booth fees: Regular booth \$100 for both days, \$20 extra for electric if available. Food Booth \$150 for both days, \$10 extra for electric if available.

HOT SPRINGS AIRPORT

Saturday, August 29 and Sunday, August 30, 2026
5 am to 8 am both days (weather permitting)

We will allow a limited number of Self-Contained food trucks to sell refreshments at the airport on Saturday morning and Sunday morning. The airport vendors may relocate to Centennial Park following the launches. Airport Vendors **must be self-contained** and provide their own lighting, as there is no electricity, or water available at the Airport location.

Aerial related activities are weather permitting.

Airport Vendor Fee: \$100 for both days. No electricity or water available.

GENERAL INFORMATION

RATES are for booth space only. All Vendors must provide their own framework, tents, shade or weather cover, display apparatus, and/or tables and chairs for their assigned spaces. At Centennial Park, such framework and sales items may be left in place within the assigned space for the night Friday, August 28, 2026, as security officers will be in Centennial Park on Friday night only. There will be a limited amount of electricity available at Centennial Park and

ELECTRICITY MUST BE BOOKED IN ADVANCE for a fee of \$20.

(\$10 for Food Vendors) No electricity available at the airport.

- We are looking for vendors with unique products to sell and we do not offer space for "information only" booths. The Chamber reserves the right to decide which booths are appropriate for the Fall River Flight Fest.
- Space is limited and preference will be given to returning vendors. If possible, please include some photos of your product/s with your application.
- At the Hot Springs Municipal Airport, vendors **MUST** be self-contained with their own lighting. There is no electricity or water available. No chairs, tables or shade will be provided. *Aerial related activities are weather permitting.*
- The festival is advertised on Television and Radio as well as with print and digital ads throughout the Black Hills as well as surrounding areas.
- The Hot Springs Chamber of Commerce, Fall River Flight Fest and the City of Hot Springs do not assume responsibility for any thefts, damages, or injuries related to rental of booth space at any venue.
- All Vendors at Centennial Park must tear down and vacate the park on Saturday night.
- The Hot Springs Chamber of Commerce reserves the right to evict participating individuals and/or organizations who do not comply with the rules and regulations of the festival.
- All artisans and food vendors must be open and available for visitors and customers throughout the open hours of the festival each day. Each artisan and food vendor must have a display sign identifying the vendor or organization.
- It is the responsibility of all Vendors to comply with all applicable SD State & County laws such as health regulations and sales tax.
