#### **Governor J. Kevin Stitt Bio**

J. Kevin Stitt is the 28th governor of Oklahoma. Governor Stitt is leading the state with a vision to become Top Ten in critical categories, from government accountability to job growth, infrastructure, education and more.

Governor Stitt is an entrepreneur and businessman who founded Gateway in Tulsa, Oklahoma, in 2000. Starting Gateway with only \$1,000 and a computer, he grew his business into one of the top 20 mortgage lenders and servicers in the nation, operating in more than 40 states and servicing more than \$20 billion in residential mortgages. Stitt led Gateway through a merger with Farmers Exchange Bank in 2018 and formed Gateway First Bank, which is headquartered in Jenks, Oklahoma, and operates more than 160 mortgage centers across the country and employs more than 1,400 people.

Oklahomans spoke in record numbers that they wanted Stitt to use his business acumen to transform the state. In 2018, he received more votes than any gubernatorial candidate in state history in his first bid for elected office of any kind.

Since taking office, he worked together with the Legislature to produce historic reform in five of the largest state agencies, allowing him to identify and recruit the best talent to serve in critical leadership positions.

More than half of the governor's cabinet is made of experts who came from the private sector in Oklahoma, including the first chief operating officer in state history.

Governor Stitt also led the state to build its largest savings account in history, which proved to be prophetic in the face of a significant decline in the oil and gas market.

He is a fourth-generation Oklahoman who graduated from Norman High School and is an alumnus of Oklahoma State University, where he received an accounting degree in 1996. Stitt and his wife, Sarah, have six children and have been married for 22 years.

## AAPL DIRECTOR'S REPORT FOR THE TAPL

The AAPL Quarterly Board Meeting was supposed to be held in Huntington Beach, California but due to restrictions from Covid-19 AAPL decided to hold the Board Meeting and the Annual Meeting virtually. The following notes are only a portion of the meeting. Should any member like to discuss more in detail, then please feel free reach out to me.

#### **Annual Meeting**

Due to the impact of Covid-19 on the economy, the AAPL Board of Directors voted to eliminate the registration fee and provide the 2020 Virtual Annual Meeting free for all AAPL members. I hope you were able to take advantage of this with 17 CEUs available at no cost!

Over 2,000 people have registered! This will have the been the largest amount of people that have ever registered for the Annual Meeting.

#### **AAPL By The Numbers**

- 15,567 AAPL members (as of 5/18/20 compared to 16,124 same time last year)
- 5,381 CPL's, RPL's, and RL's (as of 5/18/20)

#### **Education**

- <u>PENDING due to current Covid-19 situation:</u> AAPL Education Event in Tulsa November 10-13, 2020 Oil and Gas Land Review & CPL/RPL Exam. I should know more at the next board meeting in September.
- Recertification Extensions:

RL's – Certification Committee authorized a 90-day extension with certification expiration dates of 3/31/20 - 12/31/20 to earn required recertification credits.

RPL's & CPL's – there is already a 90 day "grace period" to meet recertification requirements; however, the Certification Committee has authorized a 90 day extension (total 180 days) with certification dates of 3/31/20 - 12/31/20 to meet recertification requirements.

#### **Financials**

As we have witnessed over the last several months, the negative impacts from Covid-19 have affected the economy tremendously. AAPL has also been impacted financially. The following are accounts associated with the AAPL and the dollar amounts as of 3/31/20:

- Total Assets = \$32,687,562 (down from \$35,451,181 as of 3/31/19)
- AAPL, Inc's Investment Accounts = \$26,416,329 (down from \$28,050,438 as of 3/31/19)
- AAPL Educational Foundation, Inc. = \$3,725,161 (down from \$4,261,865 as of 3/31/19)
- Landman Scholarship Trust = \$6,659,200 (down from \$7,505,592 as of 3/31/19)

- The website has federal and state bill tracking information. This is updated monthly very good information.
- Due to the increase in Landmen working in the alternative energy world, AAPL's Executive Committee and Board of Directors wanted to make sure that we are allowing those Landmen to work in this arena and maintain their AAPL membership. After much deliberation, the Board of Directors approved a change in the Landwork definition to include these individuals. The AAPL membership will need to vote and approve this change at the Annual Meeting. The new definition will be published to the membership prior to the meeting. The AAPL membership voted to approve this change.

- CONTRACT CENTER: **Keep an eye out for this!** More and more documents/contracts are being made available through the AAPL website and downloadable from Contract Center. A second round of forms has been approved and funded for preparation NPRI Ratification and Pooling. Production Sharing Agreements, Participation Agreements, and Purchase and Sale Agreements are in the works! *Membership has its benefits!*
- Contract Center's price has been decreased to \$250 per year (originally \$375) for members.
- <u>Professional Development Assistance</u>: Did you know? AAPL will provide up to \$300 per educational event, twice a year per member in reimbursement. There is no "need" base requirement for the reimbursement and any active member in good standing can apply.
- The Executive Committee has decided to terminate the Marketing Committee effective June 30, 2020 due to the AAPL staff handling most of these duties at this time. This committee has been officially terminated.
- Need Ethics Credits? AAPL has the new Ethics videos online. There are 16 new videos with a low cost of \$25 per video.
- The Board of Directors approved the proposed 2020-2021 budget. The membership will vote on the budget at the Annual meeting in June. AAPL membership approved the budget.

Next board meeting will be in Acme, Michigan – September 11-13, 2020 (or virtual).
