Something New-Financial Aid Workshops

Financial aid workshops have been facilitated by the Independent Living unit to educate our high-school aged youth about post-secondary educational and scholarship resources. The workshops have reviewed the essential higher education resources such as: the Free Application for Federal Student Aid (FAFSA), how to develop and write a college application essay, and how to budget and plan for the costs of pursuing college, trade or vocational opportunities. Youth had the opportunity to log on and complete their FAFSA application with the help from IL staff.

Also covered were, open scholarship opportunities as well as foster youth specific scholarships (ETV and Otto Huth). The staff reviewed scholarship deadlines and application materials required for submission.

The Independent Living unit has been working with their community partners in reaching as many youth as possible to provide this essential information. The first workshop was held in the computer lab at the DFS Central office, while the second convened at Eagle Quest.

Sixteen youth participants received an expandable folder containing a copy the PowerPoint presentation which included all pertinent information for application and submission of scholarship materials. Additional materials were also provided, including a flash drive containing links and resources to other scholarship resources not covered in detail during the workshop.

Future workshops will include completing specific scholarship

applications and working with high school juniors to inform them of the importance of their grades, working with their school counselors, and participation in community activities.

In the fall, the IL Program will offer the workshop again, including how to find financial aid, completing the FAFSA, and then focusing on completing both general and former foster youth scholarship applications.
