Tuition Rates: All regular fees (class, textbook, technology, and material) are included in the tuition.

Tuition Deposit:

Non-refundable 10% of total tuition is required by June 1st or at time of enrollment. The tuition deposit can be split into two payments June 1st and July 1st - contact the Business office for this option.

Tuition Deposit Policy:

1. Due **June 1st** or at time of enrollment if after June 1st (If two payments for June and July are needed, contact the Business office for a payment arrangement).
2. A \$40 late fee (no exception) will be added to the enrolled student's account if not paid by June 15th. Another late fee of \$40 will be added if not paid by July 15th.
3. Must be paid in full by the first day of school in order to attend.
4. The 10% tuition deposit is non-refundable.

Tuition Payment Options:

Plan A: A single payment for the full year due on or before August 1.

Plan B: Two equal payments due on or before August 1 and January 1

Plan C: 10 month payments due the 1st of each month beginning in August.

Past due accounts will be given a grace period through the close of business on the 5th day of the month. Accounts past due at the close of business on the 5th day of the month will be assessed a \$40 late fee. NCA may suspend a student from classes until the account is current.

Need Based Tuition Assistance is available to those that qualify. Families interested in and/or anticipating financial difficulties should contact the business office to apply.

Tuition Payment Options 2023-2024

Plan A – One annual payment in full is due on or before August 1st. If payment is not made by August 1st, the payment option will automatically revert to Plan C.

**Tuition Deposit: Non-refundable 10% of total tuition is required by June 1st or at time of enrollment.*

Plan B – Semester payments are due on or before August 1st and January 1st. If payments are not made by August 1st and by January 1st, respectively, the payment option will automatically revert to Plan C.

Plan C – 10 payments are due the 1st of each month beginning in August and ending in May.
