Judge Chinhayi Cadet

The Honorable Chinhayi C. Cadet was appointed to the San Mateo County Superior Court bench by Governor Gavin Newsom on July 9, 2021 and was sworn in on July 30, 2021. She earned a Juris Doctor degree from the Georgetown University Law Center, and a Bachelor's Degree from Stanford University. Prior to her appointment to the bench, Judge Cadet was an Assistant U.S. Attorney (AUSA) for the Northern District of California (NDCA) for nearly 20 years. Judge Cadet volunteered on the San Mateo County Bar Association's Board of Directors since 2016 and she was serving as Vice President at the time of her appointment. From 2014 - 2021, she participated as a judge in the San Mateo County Mock Trial Competition. It always warmed her heart to see the students present and learn about our justice system. She was impressed by the skill and effort exhibited by the students, and is thrilled to have the opportunity to speak at Law Day 2022.



Attorney Alyssa Daatio

Ms. Daatio graduated from the University of San Francisco School of Law in 2019, where she was awarded the 2019 Pursuit of Justice Award, given to a graduating student who has demonstrated a commitment to providing service to others in the pursuit of justice through legal experience, community and volunteer service, and service to the law school and other law students. Ms. Daatio graduated with a Certificate in Public Interest Law. She currently practices at Aaron, Riechert, Carpol & Riffle, APC in Redwood City.
