Craft In Focus is now inviting applications for their Chelsea Desire Jewellery & Silversmithing Fair being held from 10-12 March 2023. This will be our sixteenth year of Desire in London and we will once again be staging the event in Chelsea Old Town Hall.

Craft In Focus has been organising contemporary craft and design events since 2000 and is proud of the reputation gained for excellence of presentation to the public.

As well as the Desire Fairs, Craft In Focus also organises a number of mixed discipline events at a number of venues. The events have regularly been listed in the national press as being above all other events of their kind in the



UK. A strict selection process ensures only the very best professional designers, artists and craftmakers are chosen.



All work displayed must be made by the exhibitor. The show incorporates a shell scheme with fascia and name board. It is possible to hire display cabinets and lighting. Security will be

present throughout the opening hours of the show, during the build-up and breakdown as well as overnight. Porters will be available to assist with both unloading and breakdown. A fully illustrated online colour show guide is published in advance of the event and given to customers at the fair for which exhibitors are asked for a £24 contribution for the compulsory entry with image.

Set up is on Thursday followed by a Private View on Thursday evening for exhibitors' customers. The show will then be open to the public from 10 am – 5 pm from Friday to Sunday.



Covid-19

Our Covid-19 policies are constantly under review to ensure the safety of everyone, and also to provide reassurance to the public that they will be able to shop in a safe environment. Should guidance change then updates will be posted on our website as appropriate.

Completing and Returning your Applications and Deposits

You are welcome to scan and email back the completed application form instead of posting. However if e-mailing we will then contact you with our bank details for the deposit if you are selected. Please do not transfer a deposit by BACS before you receive notice of acceptance.

The shell scheme with fascia is a compulsory extra at all Desire events. It consists of 35 mm (approx) thick panels covered with a grey nylon loop fabric which is Velcro compatible. The use of nails or screws in the shell scheme is not permitted. Heavy graphics should be hung from the top using wide style picture hooks.

Chelsea – Set up will be from early Thursday 9 March in timed intervals, and some unloading is also possible on Wednesday 8 March late afternoon.

As well as overnight security, there will be a security presence within the exhibition during opening hours.

Our Desire events attract a high amount of interest from makers wishing to exhibit, and part of the selection process will take into consideration the following:

- In addition to well executed and innovative design of work, presentation will also be noted.
- Exhibitors who regularly promote their participation at events via customer mailings, advertising and actively on social media.
- Exhibitors who can breakdown within a reasonable time at the end of the show (Please advise if you are likely to take more than 2 hours to breakdown).
- Exhibitors who keep their stand display within their allocated stand space (exhibitors are not permitted to extend their display into the aisles or use the aisles as their selling area).

If accepted, all exhibitors have seven days in which to pay the deposit and to email one image which they feel represents their work which would be used in an online show guide. Exhibitors who have not exhibited with us in the past should send us a selection of images to show the style of their work, together with an image of a past display/stand.

Lighting – In the interests of the environment we are encouraging exhibitors to use low wattage lighting such as LED lamps. As such we have cut our entry level of power to just 100 watts, ample for several LED lamps.



















CRAFT IN FOCUS TERMS AND CONDITIONS 2022/2023

Your attention is drawn to 5.4.2 a breach of which may result in the exhibitor being asked to leave during the event

INTERPRETATION

In these "Conditions" the following words have the following meanings:
means any contract between the Organiser and the Exhibitor for allocation of "Contract" Display Space, incorporating these "Conditions":

means the amount notified by the Organiser to the Exhibitor for securing allocation of the Display Space;

"Display Space" means an area allocated to Exhibitors for the purposes of exhibition or display of

goods at the Event; "the Event" means the craft show / fair or any other event organised by the Organi

means any person, firm or company allocated Display Space for an Event; means Craft in Focus Ltd having its main place of business located at PO BOX "Organiser 942, MAIDSTONE, ME15 0YB.

- 1.2 In these Conditions references to any statute or statutory provisions shall, unless the context otherwise requires, be construed as a reference to that statue or statutory provision as from time to time amended, consolidated, modified, extended, re-enacted or replaced.
- In these Conditions references to the masculine include the feminine and the neuter and to the singular include the plural and vice versa as the context admits or requires. In these Conditions headings will not affect the construction of these Conditions.

APPLICATION OF TERMS

- Subject to any variation under Condition 2.3, the Contract will be on these Conditions to the exclusion of all other terms and conditions (including any terms or conditions which the Exhibitor purports to apply under any application, confirmation of allocation, specification or other documents).
- No terms and conditions endorsed upon, delivered with or contained in the Exhibitor's terms and conditions, application, confirmation of allocation, specification or other document will form part of the Contract simply as the result of such document being referred to in the Contract.
- These Conditions apply to all the Organiser's Events and any variation to these Conditions and any representations made about the Events shall have no effect unless expressly agreed in writing and igned by the Organiser.

ALLOCATION

- Any allocation of a Display Space at an Event may be revoked at any time by the organiser until the signed application together with a signed copy of these Conditions is received. A written confirmation of allocation will be sent to the Exhibitor on confirmation of the allocation. The Exhibitor must ensure that the terms of its application are complete and accurate. The Organiser shall endeavour to allocate the Display Space specified on the Exhibitor's application, but reserves the right to allocate any type or size of Display Space that is, in the sole opinion of the Organiser, suitable for the Exhibitor's purpose. Exhibitors display stand must not exceed 2.4m high.

- At or prior to the Event, the Organiser reserves the right at any time to relocate the Exhibitor if in its absolute discretion it considers such relocation necessary and in the best interests of the Event. The Organiser reserves the right to refuse any application without giving reason.

DISPLAY SPACE FEE

- Al Splay Space Fee is payable for each Display Space.

 The Display Space Fee applicable to an Event and the last date on which it must have been received in cleared funds by the Organiser shall be stated on the application.
 At the sole discretion of the Organiser, the Organiser may at any time require payment of further Display Space Fee on account of additional charges that are or may in the Organiser's opinion become due. These may exceed the Display Space Fee indicated in promotional material, application and confirmation of allocation. All additional Display Space Fee required shall be paid within 14 days of written potification. vritten notification.

 If in the opinion of the Organiser the Exhibitor's display extends beyond the allocated Display Space the Organiser may at its sole discretion charge the Exhibitor for the additional area occupied at the prevailing rate or request that the extended display be removed.
- In the event that the Exhibitor fails to pay the Display Space Fee or any other fee by the date notified, the Organiser reserves the right to impose an administration charge of £30.00 for each month, or part of, that the Display Space Fee remains unpaid. Should it become necessary for the Organiser to take legal action to obtain any outstanding amounts due the Exhibitor shall be liable for all additional costs
- The Display Space Fee is quoted exclusive of applicable VAT, subject to variation in line with changes to taxation subsequent to the date of the Contract.

 Should the Exhibitor order any additional services or use more services than that allocated or booked including, but not exclusively tables, chairs, or electrical supply, after the date the invoice for the balance of the stand fee becomes due the Organiser reserves the right to surcharge the additional service by 50% of the stated charge.

CANCELLATION 5.1 The Evhilitered

- The Exhibitor shall remain liable for the total Display Space Fee and Services once the Display Space has been allocated even if a deposit has not yet been paid unless cancellations are received in writing not less than six month's prior to an Event when he shall only forfeit his deposit. Should the Exhibitor cancel his booking less than six months prior to but more than four months prior to the Event the Exhibitor shall forfeit his deposit and in addition be liable to a further 50% of the total Display Space fee and Services. In the event that the Exhibitor's notice of cancellation is received less than four month's prior to an Event the Exhibitor shall forfeit his deposit and in addition be liable in full for the total Display Space fee and Services.
