#### **Standing Monthly Reports of Teams**

  - Janet requested a change to a motion made at the last Council meeting to reflect the correct funding source.

**ACTION: Motion made by Joan and seconded by Eloise to use Building funds (approximate cost of \$45,000) to replace a Community Center A.C. unit; motion passed unanimously.**

- There is a need for a certified financial review of FLC and FELC finances for 2021 through February 2022. CS&L CPAs has provided an estimate of \$6,500-\$8,500 to complete this work.

**ACTION: Motion made by Peggy and seconded by Grace to hire CS&L CPAs to conduct a Certified Financial Review of FLC and FELC finances for 2021 through February 2022 at an estimated cost of \$6,500-\$8,500; motion passed unanimously.**

- Property Committee – no report. Comments:
  - Bids are being obtained for upgrading narthex restrooms. Both bathrooms will be single use, gender neutral with one being ADA accessible.
  - Plans are moving ahead to replace large Community Center A.C.
- Stewardship Committee – no report. Comments:
  - Janet reported there are 78 pledges in the ICON reporting system.
  - Pastor Eric shared that he is working with Steve Ragan in planning stewardship messages to the congregation throughout the year which highlight different points in the Liturgy. Adult Forum will begin soon, meeting at 9:00am between services.

- Worship and Music – Joan Searles
  - Easter attendance was very encouraging with 65 at 7:00 service and 205 at 10:15 service. Holy Week was filled with powerful sermons and worship opportunities.
  - Joan thanked everyone for assisting/participating in the services.
  - Interview process for organist/music director continues.
- Pastor Eric's Report
  - Visitation team is being reactivated; Pastor Larry may be asked to assist.
