- **1. PAYMENT OPTIONS:** Below are three options available for paying tuition, registration, and endowment.
- **a. Full Payment Option**: You may pay tuition in full by July 20, 2018. Payment in full entitles you to a \$100.00 discount off the tuition. Registration and endowment must be paid by May 18, 2018.
- **b. 10-Month Payment Option**: You may pay tuition in ten equal monthly installments, from July 2018 through April 2019. Payments will be automatically debited from your designated checking/savings account by FACTS Management Company on either the 5th or the 20th of the month (your choice). Registration and Endowment fees may be paid separately at registration or included in tuition.
- **c. 12-Month Payment Option**: You may pay tuition in twelve equal monthly installments, from June 2018 through May 2019. Payments will be automatically debited from your designated checking/savings account by FACTS Management Company on either the 5th or the 20th of the month (your choice). Registration and Endowment fees may be paid separately at registration or included in tuition.

If there are insufficient funds in the designated account at the time of collection, FACTS will attempt to debit the designated account again on the next scheduled date. For each transaction through FACTS that needs to be resubmitted, there will be a charge of \$30.00.

- **2. REGISTRATION FEE:** Registration is \$495.00 per child/year. (Non-refundable)
- **3. ENDOWMENT FUND:** Endowment fund is \$250.00 per family/year. (Non-refundable)
- **4. MANDATORY CHILD CARE:** The schoolyard is supervised for fifteen minutes before the first bell in the morning and for fifteen minutes after the second bell in the afternoon. If a child is found on the school yard outside of these times, they will be placed in our Kid Kare Program and the person signing this agreement will be held responsible for the fees incurred.
- **5. OBLIGATORY PARENT/LEGAL GUARDIAN SUPPORT PROGRAM:** All parents/legal guardians of Our Lady of Grace students are required to participate in the Parent/Legal Guardian Support Program in this way:
 - Spend 30 hours (15 for a single parent family) in parent/legal guardian required support activities during the school year. Eight of these (four for single parent family) are required to be worked at the Fall Festival. There is a \$35 charge per hour for incomplete hours. Incomplete festival hours will be billed by January; all other incomplete hours will be billed at the end of the school year. Parent hours are tracked from the day after the last day of school of the 2017-2018 school year through the last day of school of the 2018-2019 school year.

AGREEMENT

The parents/legal guardians of the student(s) named on the front of this Tuition and Fees Contract have read the contract and agree to read the Parent/Student Handbook posted on the school website and agree to be bound by the terms and conditions of both documents. Voluntary or involuntary withdrawal from Our Lady of Grace Catholic School once the school year has begun does not dismiss the obligation to pay the full annual amount. The school year begins July 1, 2018 and ends June 30, 2018. This contract and the FACTS Tuition Collection Agreement (if choosing the Monthly Payment Option) must be signed and returned to the school office by March 31, 2018.
