G.S. 120-19 grants the legislature broad authority to access Executive Branch records. The statute says, "All officers, agents, agencies and departments of the State are required to give...upon request, all information and all data within their possession, or ascertainable from their records. This requirement is mandatory and shall include requests made by any individual member of the General Assembly."

Pursuant to our authority under G.S. 120-19, we request immediate production of the following records:

- Copies of any memos, reports, or other written material discussing components or possible components of a settlement in NC Alliance for Retired Americans v. State of NC, 20-CVS-8881 produced by you or State Board of Elections staff since Aug. 1, 2020;
- Copies of any communications, including, but not limited to, email, text
 messages, written correspondence, or recordings, between you or State Board
 of Elections staff with Marc Elias, Uzoma Nkwonta, Lalitha Madduri, Jyoti
 Jasrasaria, Ariel Glickman, Molly Mitchell, Narendra Ghosh, Burton Craige, or
 Paul Smith discussing components or possible components of a settlement in
 NC Alliance for Retired Americans v. State of NC, 20-CVS-8881 since Aug. 1,
 2020;
- Copies of any non-privileged communications, including, but not limited to, email, text messages, written correspondence, or recordings, between you or State Board of Elections staff with Attorney General Josh Stein, Swain Wood, Sripriya Narasimhan, Alexander Peters, Terrance Steed, or any other employees of the North Carolina Department of Justice discussing components or possible components of a settlement in NC Alliance for Retired Americans v. State of NC, 20-CVS-8881 since Aug. 1, 2020;

North Carolinians deserve to feel confident that the State Board of Elections will protect the integrity of their vote and fairly report the outcome of the upcoming election without interference or deception. Two members of the Board resigned this week, stating that they felt misled and key information was withheld by Attorney General Josh Stein's office regarding the settlement agreement. These events do not elicit confidence from the electorate.

The legislature has a constitutional duty to exercise oversight of the Executive Branch. Not only are these documents in the public interest, they contain information that's fundamental to ensuring that the upcoming election is held in a fair, honest, and secure manner.

You are required by state law to comply with this request. Please inform us of the expected date of production of these records by Tuesday, September 29, 2020.
