You will be writing a funeral service as homework on the second day. The hotel will have a printer available. Otherwise, you may hand write your presentation. Since there will be homework, many attendees elect to stay at the hotel. You must attend all three sessions to become certified. Upon receipt of your registration, we will send you a confirmation with other details.
