Information about the Class:

AB-54 was signed into law and took effect January 2012. AB-54 is a requirement for all Directors of **Mutual Water Companies** regardless of size. Our training meets the two-hour **AB-54 Director Training Requirement**. The specific law requires that **each board member of a mutual water company** operated as a public water system to, within six months of taking office, complete a two-hour course offered by a qualified trainer. CRWA is a qualified accredited training organization, and will cover pertinent area's relating to this law.

Class Topics Include:

- Duties of a corporate director to avoid financial conflicts of interest in contracts.
- The duties of public water systems to provide clean drinking water that complies with state and federal Safe Drinking Water Acts.
- The long term management of a public water system
