Welcome to the 2019-2020 School Year!

Gathering as a parish family to celebrate the Mass together on the weekend is the center of life at St. Veronica Parish. The celebration of the Eucharist is the reason we exist as a parish and why, as a parish, we sponsor a school. We recognize that passing on the faith to the next generation is a major part of our parish mission. For most families this is accomplished with the help of St. Veronica Parish School. We believe in the total development of the child – spiritually, academically, physically, and socially. St. Veronica Parish School continues to give its students a caring, loving environment where they grow in faith and knowledge.

The tuition rates for the 2019-2020 school year are:

Preschool

3 year old (Th & F) ½ Day \$153.00/month (\$1,525.00 annual)

4 year old (M,T, W) ½ Day \$200.00/month (\$2,000.00 annual) Full Day \$340.00/month (\$3,400.00 annual)

4 year old (M-F) ½ Day \$260.00/month (\$2,600.00 annual) Full Day \$485.00/month (\$4,850.00 annual)

(A Non Refundable Registration Fee of \$50.00 per family is required for preschool registration)

Welcome to the 2019-2020 school year registration time! This document is intended to answer many of the frequently asked questions by families each year. If you have any questions regarding tuition, please contact the Business Office at 513-688-3142.

The window to apply for financial assistance is now open. Your student could be eligible for two different scholarships; both are needs based.

- 1. Education Fund (Archdiocesan scholarship)** – Due January 31, 2019. This scholarship can be up to \$1,000 per student, and letters of award will be sent directly from the Archdiocese.
- 2. St. Veronica Parish Assistance** – Due May 6, 2019. The amount awarded depends on financial needs per FACTS' assessment.

Both St. Veronica and the Archdiocese of Cincinnati utilize FACTS (<https://factsmgt.com>), a third-party organization, to analyze family financial information to assist in tuition financial assistance decisions. By applying for one scholarship, you can easily apply for both. In fact, you are encouraged to apply for both! FACTS does charge a \$43 fee for enrolling in their system. When you apply in FACTS you are applying for both scholarship opportunities. **It is important to note that the Archdiocesan scholarship is due by January 31 and the St. Veronica Parish Assistance is due May 6, 2019. Please fill out these forms in January to take full advantage of both opportunities for financial assistance. If you normally apply for and receive parish assistance the chance that you will also receive Archdiocesan assistance is high.**

St. Veronica will make financial aid decisions in mid-May and will send letters to all who applied for financial aid. To be eligible, families must meet the "active parishioner" guidelines, i.e. Mass attendance as determined by the number of envelopes or Faith Direct cards (not by the contribution amount) and volunteer in at least one parish ministry or organization activity each year. This is not a consideration for Archdiocesan assistance.

After the FACTS online application has been completed, the following information will need to be uploaded to FACTS to complete the application process:

- Copies of your most recent Federal tax forms including all supporting tax schedules.
- Copies of your 2018 W-2 forms for both you and your spouse.
- Copies of supporting documentation for Social Security Income, Welfare, Child Support, Food Stamps, Workers' Compensation, and TANF.

All supporting documentation can be uploaded in PDF format online. Documentation can also be faxed to 866-315-9264 or mailed to the address below. Please be sure to include the applicant ID on all faxed or mailed correspondence.

If you have questions or concerns about the FACTS application process, you may speak with a FACTS Customer Care Representative at 866-441-4637.

Additional St. Veronica information:

- The St. Veronica registration fee is due at the time the complete registration forms are returned to the school office. All additional fees can be included in future payments.
- St. Veronica does not participate in EdChoice Expansion Scholarships.
- You must be enrolled in the FACTS system (if you are not paying in full) **by May 20, 2019. You are not considered registered until this step is complete.** A \$43 fee is assessed by FACTS for using their system, and a 2.85% fee is charged by FACTS for using a credit card instead of EFT. A 5% finance fee is charged by St. Veronica for monthly payments on financed tuition.
- To receive the “Active Parishioner” tuition rate, the family must attend Saturday/Sunday Mass at least 27 times per year, and volunteer for one organization, ministry, or parish-sponsored event or fundraiser. An audit is managed each year in December to check Mass attendance. If you have not met the requirement for Active Parishioner, the difference in tuition will be added to your FACTS account or invoiced
- Tuition Policy regarding delinquent payments:
 - There will be a \$30.00 fee for late payments that are received after the 15th or last day of the month, whichever is selected by the family.
 - There will be a \$30.00 fee for insufficient funds.
 - If tuition is not current and no arrangement with the Business Manager has been made prior to registration or the opening of school, the child will not be accepted into school for that year until the delinquent tuition is resolved.
 - If tuition is delinquent for **two** months, students will not be permitted to return to school until the delinquent tuition is resolved.
 - No 8th grade student may take final exams until **all** financial obligations are current.
 - No school records will be forwarded until all financial obligations are current.
 - Accounts with a history of continuous delinquency will **not** be offered the finance payment plan option the following school year.

- ☐ Copy of recent report card and standardized test results **(transfer students only)**
(We will not accept registration without test results)

IMPORTANT INFORMATION:

- **The registration fee is due at the time the completed registration forms are returned to the school office.** All additional fees (Student Fee and Technology Fee) may be included in future payments.
- **You must be enrolled in the FACTS system (factsmgt.com) if you are not paying in full.** A \$43 enrollment fee is assessed by FACTS for using their system, and a 2.85% fee is charged by FACTS for using a credit card instead of EFT. Registration Procedures

2019-2020 School Year

Registration will be accepted during the following time periods:

#1 **Beginning January 14, 2019**

- For all St. Veronica School students currently enrolled who are in grades Pre-school through 7. This period includes both “Active Parish” and “Non-Active / Out-of-Parish” students currently enrolled and attending St. Veronica School.
- Registrations for siblings of currently enrolled “Active Parish” students will be accepted at this time; siblings will be given priority in grades Pre-school through 7. If the number of sibling registrations should cause enrollment to exceed capacity at any given grade level, admissions will be accepted on a first come-first served basis from registrations received in that registration period.

#2 **Beginning January 21, 2019**

- For any parish member who wants to transfer a student from another elementary school to St. Veronica School in grades K-8. If the number of parish registrations should cause enrollment to exceed capacity at any given grade level, admission will be accepted on a first come-first served basis from registrations received in that registration period. Registration for Pre-school will be accepted at this time for parish members.

#3 **Beginning January 27, 2019 - OPEN REGISTRATION**

- For any “out-of-parish” family who wants to transfer a student from some other elementary school to St. Veronica School in grades K-8 and Pre-School.
- If the number of registrations should cause enrollment to exceed capacity at any given grade level, admissions will be accepted on a first come-first serve basis among siblings of currently enrolled “out-of-parish” students and then of new “out-of-parish” students.

It is imperative that families register during the assigned time periods in order to have optimum chance of securing admission to St. Veronica Parish School for the 2019-2020 school year.

Tuition Options

- ☐ Payment in Full (Early registration – **January 14 - February 15, 2019**)
- ☐ Payment in Full (**February 18 - May 20, 2019**) Payments are subject to **0.5%** fee per month for any partial or full month **after May 20, 2019**.
- ☐ Partial Payment (Due **May 20, 2019** – balance processed monthly same as monthly payment option)
- ☐ Monthly Payment (**July - April**) processed through **FACTS** Tuition Management and payable by EFT or Credit Card.

A \$43 fee is assessed by FACTs for using their system, and a 2.85% fee is charged by FACTs for using a credit card instead of EFT.

A 5% finance fee is charged by St. Veronica for monthly payments on financed tuition. Registration is not considered complete until payer is enrolled in FACTs by May 20, 2019.

Checks payable to St. Veronica School. A 5 day grace period will be provided for late payments. If the payment is not made within the grace period, a \$30 late fee will be accessed.
