The gun Patricia McCloskey waved at protesters was inoperable when it arrived at the St. Louis police crime lab, but a member of Circuit Attorney Kim Gardner's staff ordered crime lab experts to disassemble and reassemble it and wrote that it was "readily capable of lethal use" in charging documents filed Monday, 5 On Your Side has learned.

A St. Louis prosecutor ordered the crime lab to dismantle and then reassemble the firearm to make it functional, according to a report from KSDK-TV.

"The firearm could not be test fired as submitted," reads a report from the St. Louis police crime lab obtained by 5 On Your Side. Crime lab workers photographed the disassembly and reassembly process.

Officer Edwards shot and killed Mojarrad in a shopping center parking lot in east Raleigh on April 20, 2019. Edwards fired 11 shots at Mojarrad, stopping to reload before firing again, hitting him eight times, according to the lawsuit. A knife was found in Mojarrad's open palm as he lay dead on the ground, but the State Crime Lab found no DNA or fingerprints on it, according to the lawsuit.

A month before Verogen officially acquired GEDmatch, a team of genetic security researchers revealed a flaw in GEDmatch's relative-matching algorithm that would allow a hacker to scrape more than 90 percent of users' DNA data. Almost as soon as the acquisition went through in December 2019, Verogen CEO Brett Williams told Forensic the company has already addressed GEDmatch's previous security issues, and was committed to monitoring/correcting any other security flaws.
