No forensic evidence from the crime could reveal which brother was responsible, and police had to drop the case.

Gooden was suspended in April 2014 after alerting her supervisor, William Arnold, that she mistakenly analyzed a blood sample that had been submitted with label errors by a Houston police officer. She was suspended from casework reports while the agency investigated. Gooden continued to testify in three trials, including Diamond's, about other samples without informing prosecutors or the defense about her suspension, the court found.
