

GRANT SEASON

Tis the season for April showers and grant solicitations! This week has been very rainy where I live, and spring is in full bloom. I know this is a busy time for us all to write support letters, fill out grant applications, and somehow find the time to do your personal taxes! There are many grants with active solicitations that everyone should be aware of. Very important for every forensic lab and ME/Coroner office is the Coverdell grants. Both the competitive and formulary Coverdell grant solicitations were released last week. It is worth noting that State Administering Agencies (SAAs) should take a very careful look at this Coverdell solicitation, as there is at least one new requirement on each SAA that will be very labor intensive. The ASCLD Advocacy Committee has been very active in advocating for new grants to help forensic science, and the Coverdell authorization and appropriation is going up each year. While there is still much that needs to be done, we have made significant progress in the last few years and the Coverdell money the last two years has been significantly increased.

Other NIJ grants each entity should be tracking on would be the DNA Combined Efficiency and Backlog Reduction (CEBR), SAFE-ITR, Research and Evaluation on Policing, Prosecuting Cold Cases Using DNA, Post-Conviction of DNA Cases, and Research and Development in Forensic Science for Criminal Justice Purposes. I wanted to highlight two grants that may help ASCLD members. The “Research and Evaluation in Safety, Health, and Wellness in the Criminal Justice System” is potentially helpful to researchers or others looking into trauma and stress in the forensic workspace. This has been a big initiative for the ASCLD Board this year and we hope this grant will further that work. The “Research and Evaluation on Policing” grant may be very helpful with research regarding optimization of workforce development for officers and civilian personnel. Presumably, this grant could be used to support labs reporting to and utilizing project FORESIGHT.

Finally, I do not want labs to lose sight of the CDC OD2A grant that is open for another month. A reminder to work with your State Health Department to coordinate this solicitation. It is a huge grant for ME/Coroner systems and also toxicology labs.

ASCLD ACCREDITATION REMINDER AND MENTOR SOLICITATION

BJA has also encouraged online course offerings to save time/costs of travel, and included trainings for prosecutors, too. (Note: some NW3C courses sponsored apart from BJA funding may have a cost).
