IMPROVING SOLANO COUNTY VETERANS MOBILITY

Solano County Veterans can now access Veterans Affairs and Medical facilities, both within Solano County and several locations in Contra Costa by participating in STA's Medical Trip Concierge (GoGo) Service or the Solano County Intercity Taxi Card (STX) Program.

- Both programs are 100% subsidized
- 100% VA Income qualified
- No age restrictions
- No ADA eligibility requirements
- Wheelchair Accessible Vehicles available

Trips outside of Solano County include:

- Pittsburg VA Clinic at 102 Main St., Martinez, CA
- Medical Clinic Assessment Center at 2001 Danwood Blvd., Ste. 201, Concord, CA
- The Home Center at 1333 Willow Pass Rd., Concord, CA

Must provide proof of Veterans status by one of the following:

- Military ID
- DD214
- VA Disability Rating

*Participation in the STX program required for wheelchair accessible rides and access to Home A/R Outpatient Clinic.

- ▶ All Mobility Programs Increased in Participation Over Last Fiscal Year
- ▶ *Veterans Program Rides are currently 60% over FY21-22 with 24 trips taken since July.*
 - ▶ 15 Registered Veterans
