

# **South Shore Clean Cities NIRPC EMPC Report**

## **September 2, 2021**

1. **Micromobility:** South Shore Clean Cities Executive Director Carl Lisek presented on a Webinar with NIRPC on Tuesday, Aug. 31 on micromobility. Carl partnered with Mitch Barloga to present details on best practices for planning, safety concerns, case studies from other major U.S. cities what have implemented micromobility programs and information on the best way to achieve emissions reductions. The top take away was cities with successful programs have paired the various transportation modes – e-scooters, bikes, etc. – with existing transit stations. 2. **IDEV VW Program:** The IDEM Volkswagen Environmental Mitigation Trust Fund Committee is set to meet at 9 a.m. Sept. 14. Among the agenda items are the Round 3 Onroad-Nonroad Project scoring and selection and the Statewide Electric Vehicle Education, Outreach, and Marketing solicitation and award recommendation. You may recall IDEM initially recommended SSCC for that role but the committee decided it should go out for a full solicitation so we applied and are hopeful we will be selected. SSCC submitted nine grant requests for Round 3 through the NIRPC Green Fleet program to replace 55 diesel vehicles with alternative fuel vehicles. The total request was for more than \$5.4 million for projects totaling more than \$17.1 million. The project requests were:
  - Bulkmatic Transportation: (1) Class 8 electric truck
  - City of Hobart: (5) CNG vehicle replacements
  - City of Portage: (7) CNG vehicle replacements
  - Homewood Disposal (Gary): (5) CNG refuse vehicle replacements
  - Lake Central School Corporation: (10) propane school bus replacements
  - Michigan City Area Schools: (8) propane school bus replacements
  - School City of Hammond: (12) propane school bus replacements
  - School Town of Munster: (2) electric school bus replacements

- Scrap Metal Services (SMS) (Port of Indiana): (5) electric equipment replacements
